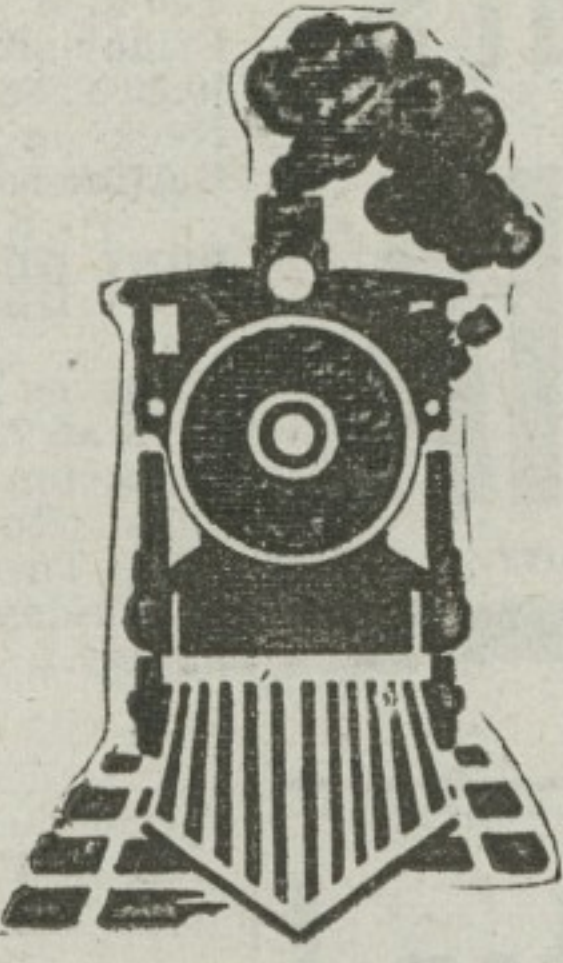

LOCAL MATTERS.

Threshing Rig and Wheat Burned.—The threshing rig owned by T. P. Devine was burned on Monday afternoon at the farm of Mr. Charles Vinyard, near Warwick, together with two stacks of Mr. Vinyard's wheat. The loss is partly covered by insurance.

Worton Manor Sold.—It is reported that Mr. William H. Cacy has purchased Worton Manor Beach farm from the owner who lives in Baltimore for \$20,000. This is one of the most beautifully located tracts of land in Kent county on the Chesapeake Bay, and contains between 400 and 500 acres. It is also reported that Mr. Cacy has 400 acres of the water front to a gentleman of Baltimore, who contemplates improving it for a summer home.

Attempted Assault.—Joseph Jones, colored, was arrested at Betterton on Wednesday night on the charge of attempting to assault the twelve-year-old daughter of Mrs. Wickesser. The mother and child were walking along the board walk about nine o'clock when the negro rushed up and grabbed the child. A struggle ensued in which the girl's slipper came off, freeing her from the brute's grasp. He was arrested by the officers and is in Chestertown jail awaiting the action of the grand jury. Jones is a notorious character, living in the vicinity of Still Pond. He was arrested by Constable Alfred Jester, he had the child's slipper in his pocket.

Schooner and Captain Lost.—The schooner Carrie and Belle was lost off Wolf Tea, Virginia on Sunday and the Captain, Thomas H. Wright, was drowned. The boat was loaded with coal from Hampton Roads for Baltimore. Capt. Wright had recently suffered a slight paralytic stroke and his relatives believe that he was stricken again while at the wheel. Capt. Wright was well-known in Chestertown where he had frequently freighted coal. It was his vessel that took a party of Chestertown men, of which the late J. K. Aldridge was commodore on a cruise to Norfolk and Old Point some years ago. He was a splendid man and formerly lived in Chesapeake City.

Mr. Walter H. Hadaway is having erected on the lot adjoining the store of Mr. Marion T. Miller in Rock Hall an attractive ice cream parlor.

The packet which has been freighting between Rock Hall and Baltimore has discontinued its trips for the remainder of the summer.

Mr. W. T. Byrd, of Baltimore, has purchased of Mr. Joseph Davis, of Rock Hall, a dead rise bateau, 45 feet by 10 feet, which he will convert into a pleasure yacht.

Messrs. Porter & Harding, the wholesale and retail candy and confectionery store, which has been removed from the Edwards building to the room on High street adjoining Mr. H. B. Rote's jewelry store, near the postoffice.

Mr. Harry R. Graham shipped 15 fine sheep to a gentleman in Richmond on Wednesday night. Among them were 10 young bucks for which he received \$180.

The state officers of the Jr. O. U. A. M. will visit the local order on Wednesday, and a full attendance of the members is especially desired, so that the visitors may have a fine reception.

Expressman John E. Matthews lost his valuable black horse on Wednesday night from the effects of colic. This is his big loss to the popular expressman, as his horse was a valuable animal.

The steamer B. S. Ford carried to Baltimore market on Monday between 700 and 800 packages of peaches, and shipments for other boats days have also been good.

There will be a meeting of the Modern Woodmen of America in Fraternal Hall next Thursday evening at 8 o'clock. All members are requested to be present.

The frame building at present occupied by the Kent County Savings Bank will be torn down next week preparatory to the erection of a modern bank building, the plans for which have been designed by architect Leach, of Baltimore.

The Annual County Teachers' Institute will be held in the high school building Sept. 6 to 11. Prof. McVinn has secured Mrs. Adams and Mrs. Clark, of Baltimore, for one of the delightful recitals for one evening of the institute.

Buyers have been in the county during the past two weeks buying keiffer pears at 15 cents per basket. Mr. Harry Legg of the Chapman-Pearce farm sold his orchard of 3000 baskets for 15 cents. There is a fine crop of pears in the county this year.

Trainer John Mallalieu leaves today for Pocomoke Fair, where most of his fine string of racers are entered in the various purses next week. He carried John B. Lady Bess, Hattie C. Col. Hunter and other fast ones, and we are sure that the "men in many of the races. Owing to the warm weather and the great demand for ice, Mr. Robt. G. Nicholson, proprietor of the Chestertown Ice Plant, has installed new machinery which will enable him to make 20 tons of ice per day. Heretofore capacity has been 12 tons, and last Saturday the demand completely exhausted the supply.

The "Lemon Buds" a newly organized base ball team, journeyed to Rock Hall on Saturday last and were beaten by the score of 8 to 5. The "Buds" have a strong team, and they would like to hear from all teams in the Address Wilmer B. Coleman. They go to Crumpton to-day.

Milk Good—Water Suspicious.

County Health Officer Dr. H. G. Simpson received a telegram from the State Chemist yesterday morning announcing that the milk supply of Chestertown is good, and precautionary measures have been taken by Mr. Morris and Mr. Storey to keep the supply of milk in a wholesome condition. The Health Officer was ordered by the State authorities to order the shutting off of the second spring of water at the pump house, so that the only source of supply which the town now has is in the means of a very limited quantity of water for the town and all efforts will have to be made by the water users to prevent waste of any kind so that the users may get any water at all. A serious condition of water supply confronts the town. The TRANSCRIPT has been censured very violently in past years for opposing the planing of the town's water system in a place which receives the drainage into its springs of out-houses and slaughter houses, and yet the people are waking up to the situation that the TRANSCRIPT was right in its contention, and the sooner the people do something to remove the system from its present location the better it will be for the general health of the community. In this position we are backed up by the authority of the State Board of Health, which has always contended that the town's water system is in the wrong place and should be made so as to depend upon artesian well water all together. It is up to the people of the town to take some immediate action looking to the borrowing of money to place the system in such condition as it should be.

Mr. Thomas Re-appointed.

Mr. M. Wilbur Thomas received a telegram from State Chairman John B. Hanna on Thursday morning announcing that the President had re-appointed him postmaster at Chestertown for a term of four years. The term of postmaster Thomas, expired nearly a year ago during which time there has been a quiet though stubborn fight to oust him. There were several candidates for the place, and former Congressman Jackson was appealed to in behalf of some one other than Mr. Thomas. Mr. Thomas' past very excellent record, the endorsement of the patrons of the office and the very powerful influence of members of the State Central Committee and of the leaders of the party in the State assured Mr. Thomas of re-appointment. Mr. Thomas has made a most excellent postmaster and he has kept the affairs of the office in perfect order during his term. His re-appointment will be for four years from the date of his confirmation at a salary of \$2,300 per annum. Mr. Thomas has also received full pay for the time during which his appointment has held over. His re-appointment is a recognition by the President of the Townshend-Elison element of the party in Kent. We congratulate Mr. Thomas on his re-appointment.

Change Place of Meeting.

A meeting of the executive committee of the State Camp P. O. S. of A. was held in Baltimore on Monday, when it was decided to change the place of meeting from Chestertown to Baltimore, owing to the prevalence of typhoid fever in Chestertown. The decision of the committee is much regretted by the local camp members who have gone to considerable trouble and expense in preparation of entertaining the State Camp. The decision will also cause considerable loss to our merchants and hotels here.

TO WATER TAKERS.

In order that the citizens of Chestertown may have nothing but pure water, upon the advice of the Health authorities the lower pool has been cut off. This action reduces the water supply over 20,000 gallons per day, and has caused the discontinuance of the sprinkler. It is therefore earnestly requested of all water takers not to allow hydrants or spigots to run any more than necessary and to be as economical as possible in the use of water. It is absolutely necessary that this notice be observed, otherwise there may be a dearth of water, and no one wishes such a condition. The analysis of the present supply was perfectly satisfactory.
