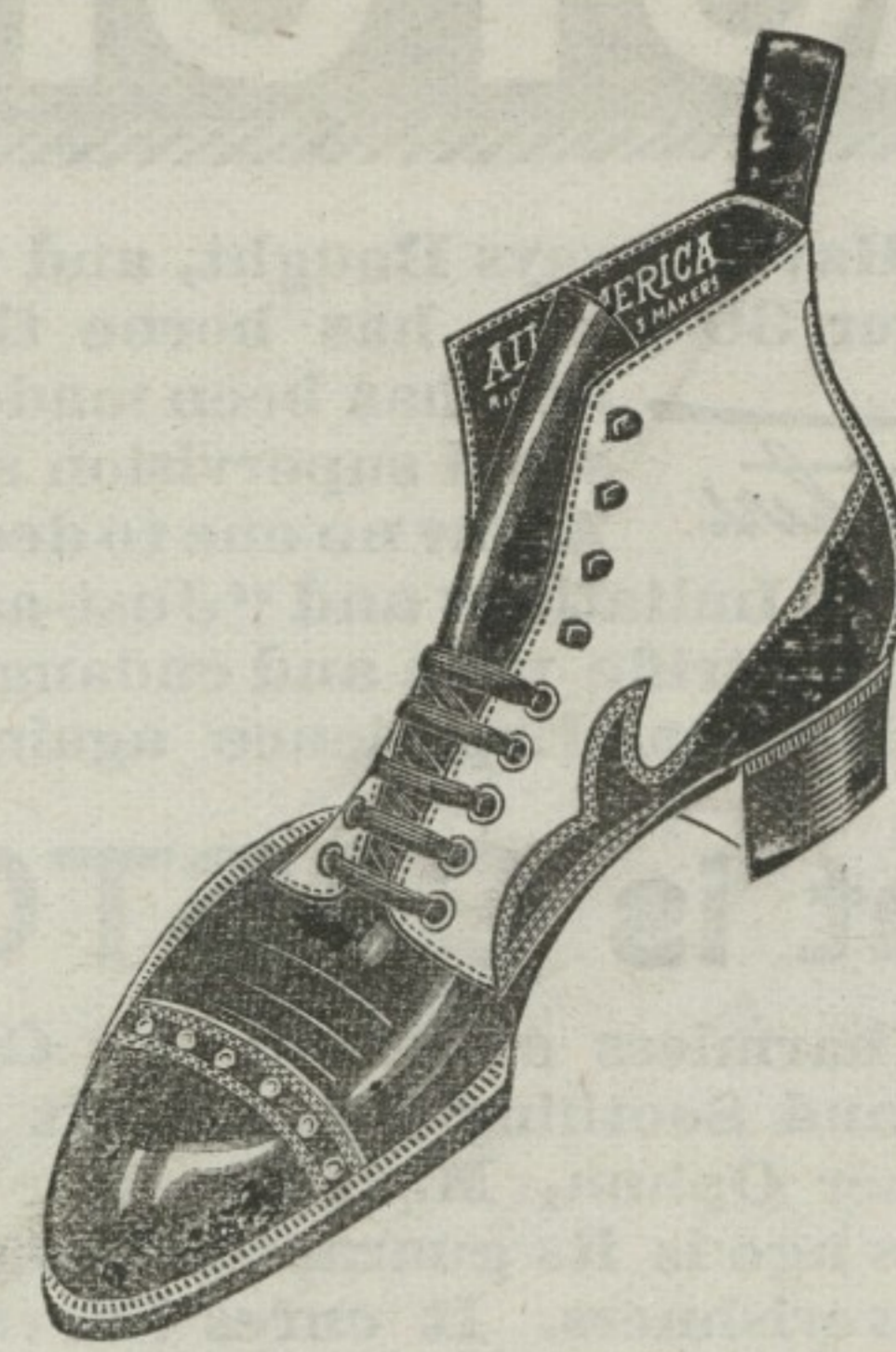

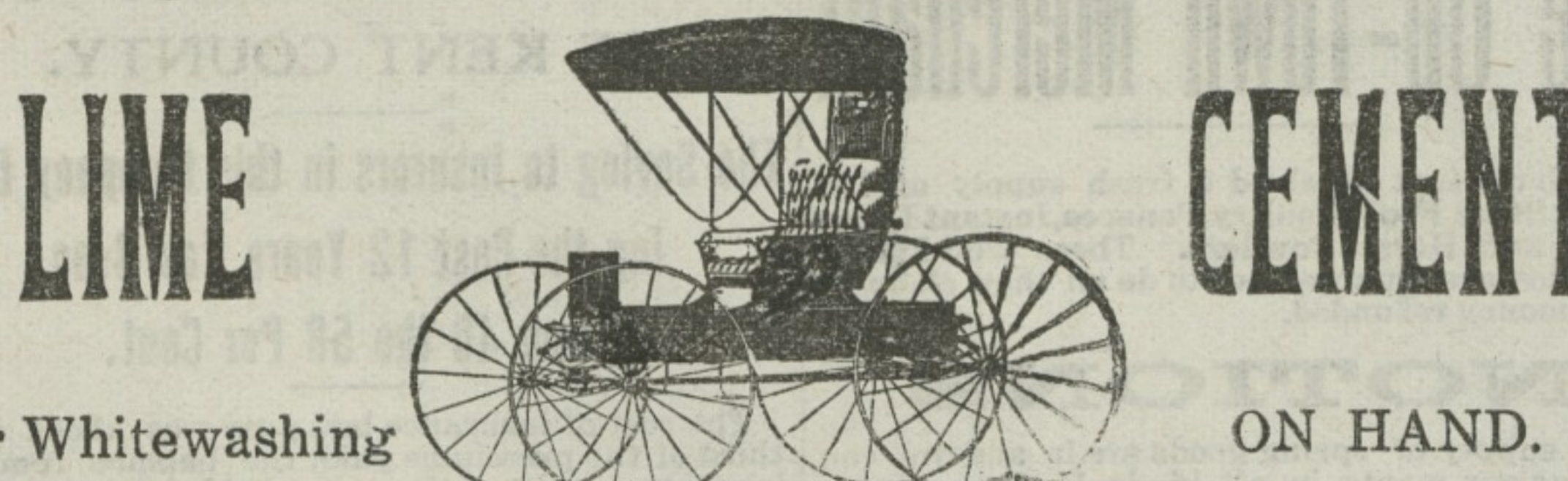

### LOCAL MATTERS.

**Found Dead in Tomato Patch.**—An aged colored man by the name of Hudson was found dead in Mr. A. L. Hudson's tomato patch, near Fairlee, on Monday morning by a colored woman. The man had evidently been dead some time, when found, and death is supposed to have been due to heart failure. Undertaker J. E. Ferguson buried the remains on Wednesday. The man was on his way from church in Georgetown to Fairlee, and died in the patch on Sunday night.

**Arrested in Wilmington.**—George Hayes, 24 years old, charged with violation of the local option laws in Kent and Queen Anne's counties, Maryland, was arrested in Wilmington, on Wednesday. A bench warrant for the accused was received by the Wilmington authorities from the Circuit Court of Kent county Maryland, in addition to a warrant charging him with selling liquor in the Seventh Election district of Queen Anne's county to George Deaton. He will be tried at the October term of Court.

**Important change** of schedule of the Tolchester company to become effective October 2, is published in this issue.

**The farmers** of the county are up to their eyes in work, cutting corn, plowing fallow, and winding up an unprofitable tomato crop.

**Contractor Frank E. Duyer** is arranging plans for the erection of a handsome \$50,000 residence on one of our farms near Lankford.

**The tomato season** is nearing its close. It has been an unprofitable one for both growers and canners, on account of weather conditions.

**Several of the farmers** of the county have horses suffering with spinal meningitis. A veterinarian has been in attendance and they are improving.

**Mr. J. Walters Russell**, real estate broker, sold this week the farm of Mrs. Annie Moffett, near Worton, containing 42 acres to Capt. Penn Jester.

**Mr. and Mrs. Wm. A. Burk** have a beautiful night blooming cerise which has been attracting much attention at their home on Cross street.

**A mud machine** has been at work at Mr. H. P. Skipper's wharf near Chester bridge during the week, digging a channel for the passage of freight boats.

**Mr. Claude Parks** has joined the automobile fraternity and has ordered a fine Maxwell machine through Mr. J. H. Sides, the agent. There'll be others shortly.

**Ex-Senator Garrett Foxwell** has presented to the Hibernia Public School a very handsome map of the United States similar to the one he gave the Chestertown High School.

**County Treasurer Thos. Gale** is removing from his farm in Worton this week to the residence on Front street formerly occupied by Mrs. Solomon.

**William Willis** will till Mr. Gale's farm next year.

**While assisting** to extinguish the blaze at the fire on Monday morning, Mr. Wm. T. H. Whiteley was severely cut on the knee cap with an axe. He has been under medical attention since, and is improving.

**Several wealthy Pennsylvanians** have been in Chestertown during the week conferring with our real estate brokers relative to purchasing desirable water-front homes on the river or bay.

**Develop the business**, there is barrels of money in it for the brokers and for the county.

**Fire on Monday morning** at 11:45 damaged the house on Queen street belonging to the Robinson (colored) estate. The fire company extinguished the blaze within seven minutes after the alarm was given. The house was occupied by colored people, and there was no insurance.

The Keiffer pear crop in the county will be a good one this season and most of the farmers have sold at a profit. The crop will begin to move about October 1.

**At a special meeting** of the Chestertown Conclave no. 371 Thursday evening, Mr. Jacob F. Thompson was elected financier to succeed the late Joseph N. Wheatley.

**The company** of Chestertown and Worton folks did not enjoy the day at a fish fry and oyster scald at the Cliffs yesterday, but the invitations held good for a day next week to be announced later.

**Relatives here** of those people from Chestertown who are now living in the South which has been visited recently by a terrific tropical storm have been very much concerned for their safety during the week. Nothing unfavorable has been heard from them and it is believed they are all unharmed.

**Mr. S. J. Seneca** and friend, Havre de Grace, one day last week off Sputea Island caught 9 rock fish which weighed 116 pounds. Two of the rock weighed 22 pounds apiece and were landed with a rod and reel. Taylors are biting fine at Love Point, and are being caught in large quantities in nets off Rock Hall and Tolchester.

Hines, Mr. Charles Jessup, and the youngest children of the late Mrs. Wm. B. Wilmer.

**One of the large plate glass** in the candy kitchen window was broken on Saturday night by a colored boy who got into a fracas with another. A brick thrown by one of the boys at the other missed the boy and went through the window. Somebody is \$50 or \$75 out. Such rowdiness on our streets especially on Saturday nights, should be stopped by our town authorities. There is entirely too much loafing allowed on our street corners on Saturday nights. No other town the size of Chestertown allows it, and it should not be permitted here.

### To Dedicate Municipal Building.

Final arrangements have been made by the Volunteer Fire Company of Chestertown to dedicate its handsome new municipal building on Monday, Oct. 11. Chief Judge James Alfred Pearce has consented to deliver an address in the morning, the Jr. Order of United American Mechanics, which has presented a handsome flag to the company, will have a flag raising and other interesting exercises in the afternoon and in the evening a splendid reception has been arranged, and the handsome auditorium will be thrown open to the public, an orchestra will be in attendance during the evening and refreshments will be served. A general invitation will be extended to the people of the town and county to attend these exercises and to enjoy the hospitality of the Fire Company in the evening. The building was illuminated Saturday evening for about one hour and presented a beautiful appearance. The dome of the building is surmounted by four large electric globes, which stand out as beacons of light. ### To Have Industrial Learning.

Arrangements have been made with the School Board of Kent County and the trustees of the colored school in James M. E. Church, Chestertown, for the introduction into the course of industrial training for the colored pupils. The Comptroller of the Green Fund, has employed a special teacher to instruct the pupils in needle work, cooking and other useful arts, and this teacher began her duties in the above school on Monday morning last. The school authorities of this county are at no expense at all for the introduction of this course in the colored school, except to provide a room in the school building, which has been done, and also to provide a few minor articles. The fund will provide all the expenses including the salary of the teacher. This is a most excellent movement for the education of the colored children and the School Board is to be congratulated that it has taken the matter up. There is no more useful education for colored children than to teach them to work and to learn to be self supporting and every colored child should accept the opportunity which a benevolent fund has provided. The course is meeting with great success among the pupils who seem to be anxious to learn the useful arts.

**Quite a number of our young folks** attended the Barlow & Wilson minstrel show in Stam's Hall Monday night, and thought it real good.

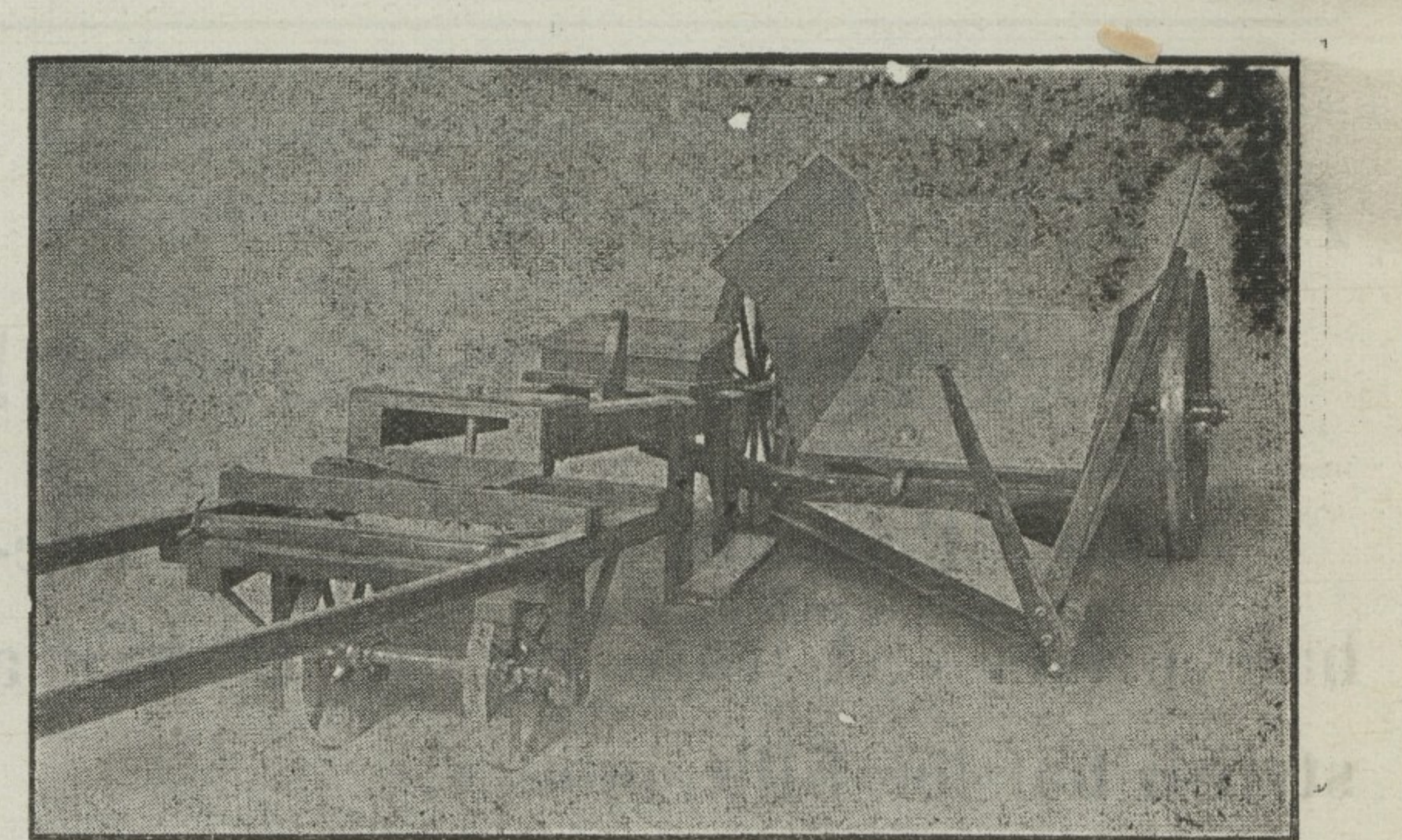

### Defies The Drought By Irrigation.

**Fred Maguire**, a farmer who moved to Delaware from the Northwest, bringing some good Western ideas, has overcome the drought and now laughs at the Eastern farmers who pass his place and stop their horses to survey his beds of lettuce and his beautiful lay-out of market gardening. Maguire lives on Silver Lake farm and he has harnessed the water of the lake and irrigated his place.

**A gasoline engine**, with a two-horse power pressure, forces the water from Silver Lake up through a pipe system which irrigates Maguire's farm. It can turn on the water in one set of pipes and it sprays out, so that he has "rain" at will. He can turn it on another pipe line and water his stock and grass and flowers. All Maguire has to do is to feed his engine and turn his pipes, then get out and hoe. Neighbors who have seen it declare that the system works perfectly. —Del. State News
