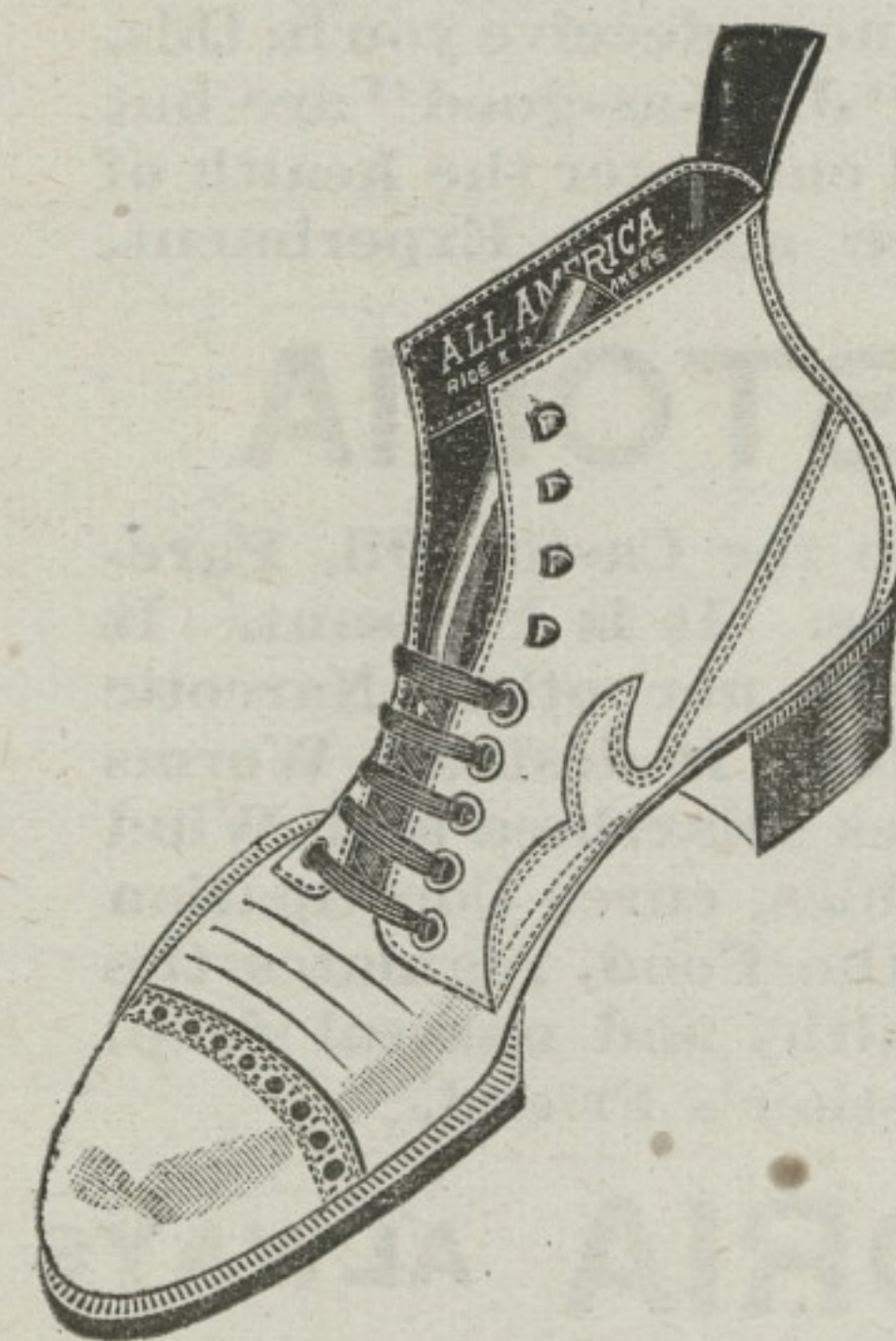

LOCAL MATTERS.

Purchases Piers.—The Baltimore, Chesapeake & Atlantic Railway Company, of which the Chester River Line is a branch, has purchased of the Safe Deposit and Trust Company, Baltimore, trustee for the estate of Samuel Burns, Piers 4 and 4 1/2 Light street, fronting 83 feet. The consideration was \$70,000.

Accused of Violating Game Law.—Mr. Orrie Stevens, of Rock Hall, was arrested on Wednesday by Mr. S. C. Jones, secretary to State Game Warden Harmonson at Abbey Island Shoals near Poole's Island, on the charge of pursuing in forbidden waters in the Chesapeake bay. Stevens was arrested on July 16 on a similar charge and was out on \$500 bail when arrested.

Cecil County Has a Surplus.—The annual statement of the Board of County Commissioners of Cecil county made public this week shows the receipts of the county the past fiscal year to have been \$197,992.96, while the expenditures amounted to \$186,636.63, leaving a comfortable surplus in the county treasury. This shows good management on the part of the county officials.

Broke Blood Vessel.—Mrs. Thomas J. Davis, of Flatland, met with a peculiar accident on Monday. Mrs. Davis was engaged in her household duties and went to reach above her head for something when a blood vessel in her arm suddenly broke. Mrs. Davis suffered a great deal of pain before the arrival of a physician, who rendered medical aid, and Mrs. Davis is doing well.

Delaware hogs are reported to have contracted the measles. Delightful weather for seeding wheat, but just a trifle warm, there is danger of fly.

Wheat was quoted in Baltimore, yesterday at \$1.17 1/2 per bushel. Looks like it will reach \$1.25 by Christmas.

Big racing next Thursday, Oct. 14th, at Rose Hill track. Some fine racers will be seen in the classes.

Mr. Frank B. Hines has traded his Maxwell automobile for a Hupmobile. It is the first of the kind owned in Chestertown.

Mr. J. H. Sides has accepted the agency for the Studebaker automobile and already has several good prospects of sale.

Five and a half tons—63 boxes—of fine rock fish were shipped from Tolchester wharf on Monday. They were caught in pound nets.

The social season in Chestertown this winter promises to be gay. Numerous entertainments, socials, etc., are being booked. Better get your date fixed.

Chestnuts are ripe but the crop in this section is not large. They are selling for \$15 per bushel in city markets. Why don't some one grow them for profit here?

Gov. Crothers has declared Tuesday next, October 12th, Columbus Day, a legal holiday, and the banks and all public offices will be closed on that day.

The Vickers farm in Broad Neck advertised in the Transcript was offered at public sale on Tuesday by Harrison W. Vickers, Jr., trustee, and was withdrawn on an insufficient bid.

Keiffer pear shipments have been extremely heavy during the past two weeks. A special freight train was required last Sunday to relieve the pressure on the local road.

It is estimated that there will be two-thirds of a corn crop in this section of the county, while in the vicinity of Massey and Millington the crop is full. Queen Annes also has a good crop.
