The Maryland Legislature is a thing of the past. Now Mr. Tax-payer, you may "take stock" and see where you stand.

For the benefit of the merchants of the county we state that the trading stamp bill, which prohibits the giving away of trading stamps and other such coupons, has passed and been signed by the Governor.

MRS. MARY FRANCES SMITH, wife of United States Senator John Walter Smith, died at the home of her daughter, Mrs. A. D. Foster, at Roland Park, Baltimore, on Tuesday night, of heart trouble. Mrs. Smith was a Miss Richardson, of Snow Hill.

THE BALTIMORE SUN well said editorially on Sunday.

"A fearless newspaper moves in a swarm of enemies. The more the better, provided they are made in a public cause."

It may be added that enemies are often made because the paper has the courage of its convictions, and does not hesitate to state the truth about matters of public concern. The truth hurts, and the enemies who malign the paper or men who dare to tell the truth, are stung by the force of the truth. Such enemies do a paper far more good than harm.

IN DISCUSSING editorially in our last issue the law passed at the recent session of the Legislature compelling the Water Board of Chestertown to carry out the recent report of the committee of citizens in reference to improvements to the water plant, we said "Mr. Eliason knows the town bought a gold brick when it purchased the plant at the fabulous sum of \$24,000. He held the bonds then." Mr. Eliason called at our office Saturday morning and told us that we misstated the facts about his holding the bonds. He said he held one-third of the bonds, and held another third as collateral. We are glad to make the correction.

IT IS reported that Mr. Thomas L. Hines, nephew of Dr. W. W. Hines, of Baltimore, is an applicant for road engineer of Kent County under the Slay bill. Mr. Hines is a young man 27 years old, and is fully qualified to fill the position because of his experience in road construction in several of the largest cities in the country, and because of his executive ability. We believe that should Mr. Hines secure the position he would use his influence to devote the roads from politics, and would endeavor to place the system of road working in this county on an economical basis. It is said that strong influences are already at work for Mr. Hines. There are several other prospective applicants.

THERE WAS a hilarious time in the House last Friday. The members had been laboring under a heavy strain for three long months, and having grown weary with their arduous duties (?) gave themselves over to hilarity and jesting. The voice of the Speaker and Reading Clerk could scarcely be heard above the din, and numerous bills were pushed through with little or no attention paid to them. Some bold bad fellows scattered a lot of red pepper about the chamber, and when the pepper got to going good and fast it put the members on the sneeze. It was during the sneezing fit and hilarious uproar that the Slay road bill was passed in the House. It is now a law, and when the engineer begins his work in Kent, it will cause a warm time among the tax-payers and road workers.

THE Maryland Legislature closed on Monday night. It is needless to say that its acts will be criticised by the Republican press throughout the State, and yet it should be remembered that the Republicans were in the great minority and for party purposes they must criticise rather than commend. We do not hesitate to say that the Legislature did some things which it should not have done. That is natural. A body of men is like an individual—liable to err. But on the whole the Legislature of 1910 will compare very favorably with its predecessors so far as its actions relate to the State as a whole. The Legislature made a great effort to redeem the party pledges, and whatever may be said to the contrary, they succeeded admirably. The Pure Food Bill, the State-wide Primary law, applying to both parties, and the State banking law, are excellent pieces of legislation and will do much toward making the Legislature of 1910 a remarkable one.

NEVER BEFORE in the history of Maryland have so many exciting incidents occurred in the Legislature as were pulled off during the past session. The most significant occurred early last Sunday morning during a strenuous fight on the Public Utilities Bill, when Senator Blair Lee made an effort to unseat President of the Senate Arthur P. Gorman and to place in the chair Senator Goslin, of Caroline. Senator Gorman was accused of "playing politics" with the utilities bill, and was using his efforts to defeat the measure. Senator Lee had the votes, and had he listened to the arguments of Senators Harper, Slay and a few others, he would have pressed his motion to unhorse Senator Gorman. It looks like this incident will put a black eye on Senator Gorman's "try" for the Governorship in 1911. The Senator has stated that he desires to return to private life.

IT MAY be said to the very great credit of the People's faction of the Democratic party that they play the game of politics fairly and squarely. They never resort to any unfair or revolutionary methods to gain a victory, and whatever they do, is done openly and without malice aforethought. Not so with the Organization. The passage of the Slay road law is as unfair to the people of this county, and as revolutionary in its tendencies as anything that has been done in the county for years. It is unprecedented in the history of the county, and cannot fail to work to the disadvantage of those who have resorted to such unfair, unjust and unscrupulous means to retain possession of what they believe to be the greatest political lever in the county—the roads. The People's faction won by every fair and honest means, the Board of County Commissioners, and they should have been allowed to enjoy the spoils of their victory. They never objected to the Organization element doing likewise when they won a victory, and in all fairness and honesty the Organization leaders should never have foisted such revolutionary and unpopular methods of working our roads upon the tax-payers and depriving the people of their rights, simply for the sake of retaining control of the party machinery. Their actions will prove a boomerang, and the working of their law will prove their undoing, or we badly misjudge public sentiment. Honesty is the policy that will win every time. Don't forget that.

IS THIS THEIR REASON?

A gentleman, who has always been identified with the Organization element of the Democratic party was in our office this week, discussing the character of the bills passed in the Legislature affecting Kent county. He characterized the bills as "infernal bills to take money out of the tax-payers pockets" and said: "The reason they passed the Slay Road bill, the bill for changing the method of recording deeds, the bill requiring the treasurer of Kent county to keep six different accounts by depositing his money in all three banks, and the bill increasing the cost of boarding prisoners, all of which mean great expense to the tax-payers of the county, was to get even with Hope H. Barroll, for exposing the conduct of the Organization element in squandering so much of the tax-payers' money from June 12th to Dec. 1, 1909." Said he: "Why, what do those fellows care for the interests of the tax-payers? All they want is to get a slap at Barroll for the interest he has taken in the tax-payers of the county." If the statement of this gentleman is correct, and we have not the slightest reason to doubt his veracity, Hope H. Barroll, Esq., who has had the courage and the interest in the welfare of the people of the county generally, to expose the methods employed in the commissioners office by the Organization forces to retain their power in this county, will be all the stronger and all the more popular with the people, when the tax-payers learn, as they surely will, that nearly every bill passed by the Organization representatives in the Legislature affecting Kent county, calls for a large expenditure of the people's money, and offers no relief from the political manipulation of our county roads. Mr. Barroll is to be commended for his fearless stand in behalf of the people, and if the object of oppressing the tax-payers any more than they have been in the last nine months, is to get even with Mr. Barroll, such action will serve only to strengthen Mr. Barroll with the people, and injure those who are responsible for the passage of such bills as have been inflicted upon the people of the county.

THEIR RESPONSIBILITY.

Whatever may be the effect of the passage of the Slay road bill, and every other bill for that matter, the Organization forces must bear the responsibility for their passage. THE TRANSCRIPT, by its publication of the Caroline law, and by its arguments and letters from residents in Caroline county, created a powerful sentiment in this county for the adoption of the Caroline law. The sentiment for this law was so great that petitions were eagerly signed by more than 600 of our tax-payers and representative citizens asking our representatives in the Legislature to pass the Caroline law. It is of no use trying to say that they asked for a road law somewhat like the Caroline

law. Not a single signer to these petitions ever dreamed of signing a petition that would create a law legislating the roads of the county and the expenditure of their money in the hands of a man who is in nowise responsible to the Board of Commissioners or any other body in this county for his acts. Mr. Harris, impressed with the character of these petitions introduced the Caroline road law in the House. It was killed in committee, because we understand Mr. Willis was opposed to it, and Mr. Murray, from Worcester county, who was on the delegation to whom was referred the bill, refused to take side with either Mr. Harris or Mr. Willis.

The Caroline Road Law was killed in the House committee. Mr. Slay introduced his road law some weeks after. It was passed in the Senate on Friday, sent to the House and passed on Saturday evening and is now a law awaiting the Governor's signature. Just who is responsible for the passage of this Act is well known to the people, but it would be an interesting bit of reading if Senator Slay will have published the list of those tax-payers and representative citizens who asked him to pass his bill. The Organization is responsible for this great revolution in county government. Let them stand by their guns.
