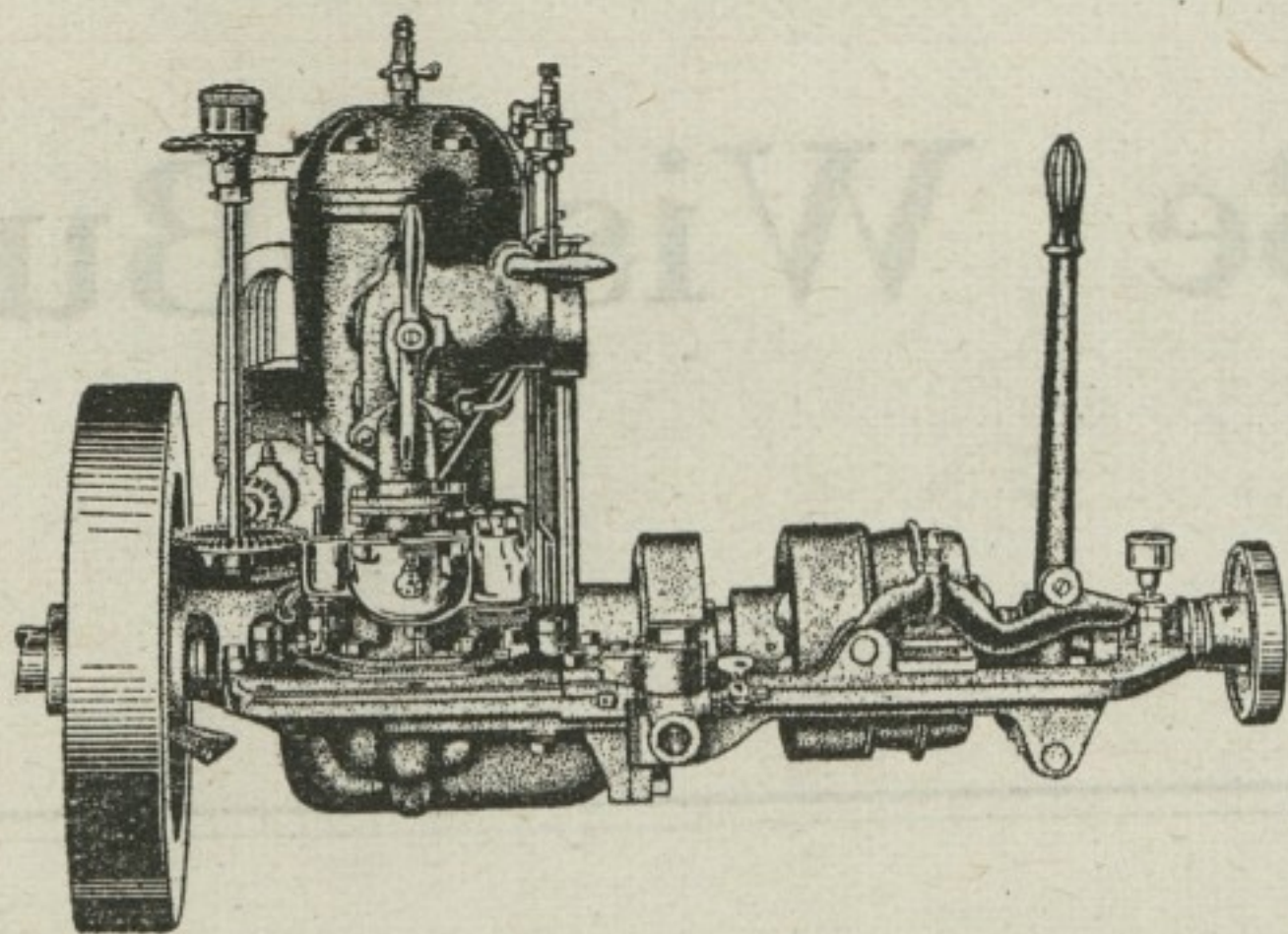

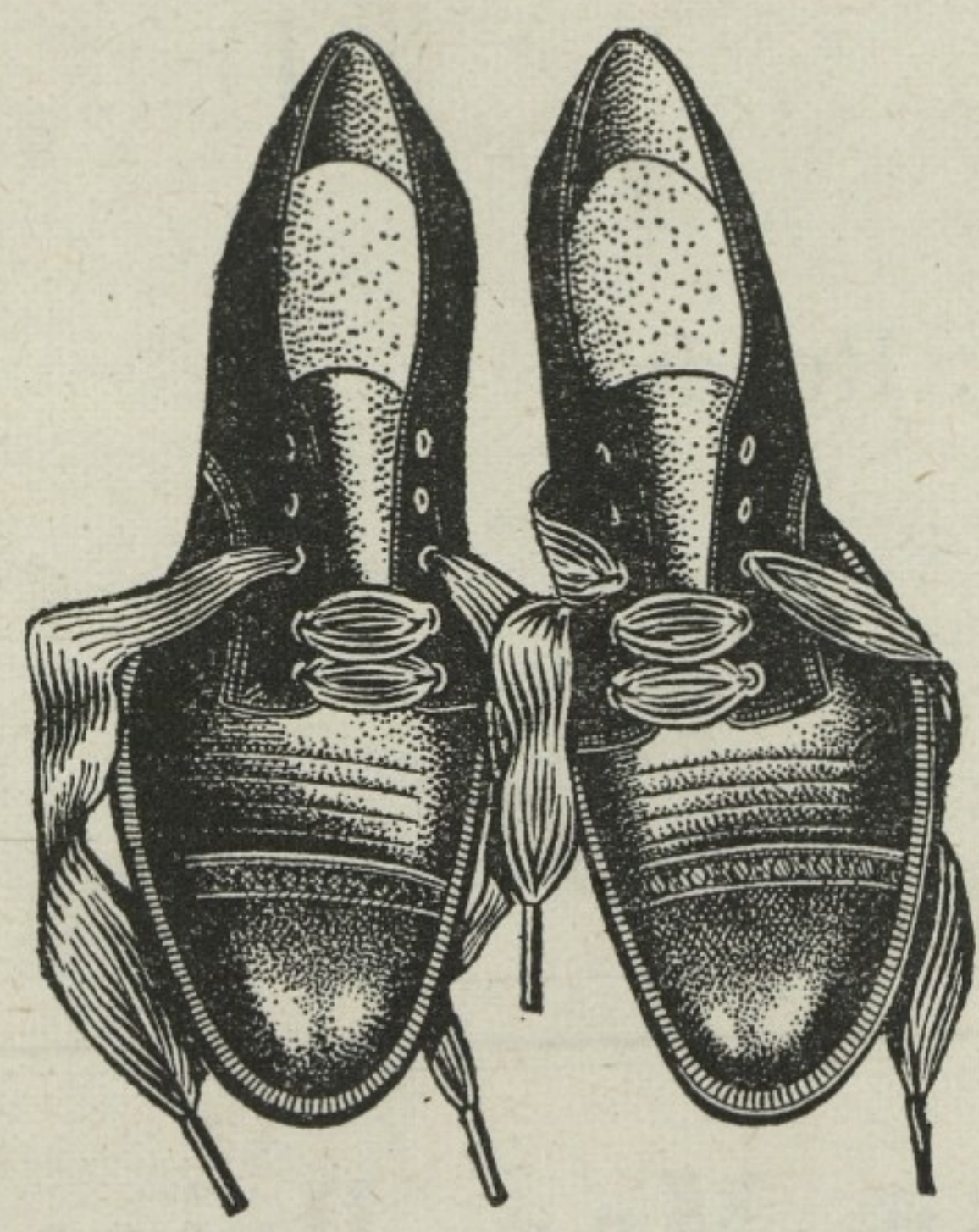

—Mail driver, Mr. W. B. Ashley on last Monday morning met with a slight accident on his way down to the Grady post office. The front wheel of his buggy came off which caused him to fall from his team. He received several bruises on his face and arms.

—A large delegation of patrons and tax-payers from Quaker Neck and Pomona appeared before the School Board on Tuesday in reference to closing the schools Nos. 1 and 2, and erecting a school in the village of Pomona. The Board is holding the matter under consideration.

—The Chestertown Aggregates went to Millington in Collins Brothers' launch last Saturday and defeated the Millington second team in an exciting game of ball. Score 12 to 4. Jarman and Harris proved a winning battery for the Aggregates, with Jeter and Davis for Millington.

—Messrs. Thos. D. France, J. E. Ferguson, J. Hyde Thompson, J. H. Sides and Mr. Horn attended a special communication of the Synod of A. F. & A. M. in Smyrna, Del., on Thursday evening making the trip in Mr. Sides' big touring car. Mr. A. L. Messers' Wood Masson, of Wrightson, McDonald and Dr. Hughes in his car. They had a delightful trip.

—If the tail of the comet struck us, nobody in Chestertown felt it. Probably 100 people sat up on Thursday night to see the celestial phenomenon Thursday night but not one, except Mr. Harry Boyd, who went out to the old depot to get a look, saw it. Mr. Boyd says it was the most beautiful heavenly sight he ever saw. Five hundred people stood on the bridge at midnight, but they didn't see a thing.

—Officer Cooper arrested William Waters on Monday on the charge of violating the local option law. The officer made a raid on Waters' house and found nearly a barrel of whiskey, numerous beer bottles, etc. Waters, besides serving a term in the penitentiary, has been sent to the House of Correction several times for selling intoxicants. He is held for court, and it would be a blessing to the community if he could be sent somewhere where he could never return to Chestertown. Vannort, who had the first sweet pea show in town, Mrs. J. T. Twilley and Mrs. Hope H. Barroll, whose grounds, lovely flowers, and rare shrubbery, are always objects of the greatest admiration.

—At the last meeting of the Board of Town Commissioners passed an ordinance requiring that all pavements hereafter laid in the town shall be of cement. The new walks from College avenue to Culp's factory and from High Street to the Meteor house on Front street will be of cement. This is a commendable move on the part of the commissioners, and evidences the fact that the impossible is being done. The ordinance will be published next week.

OBITUARY.

MR. WILLIAM E. JARRELL.

Mr. William E. Jarrell, one of our most prominent citizens and one of Kent county's most highly esteemed business men, died at his home on Washington street, Saturday morning, of an illness of several months, of heart failure, aged 64 years. Mr. Jarrell had been feeling somewhat improved in health the last week, and he expressed a desire to see several of his tenants. On Saturday morning he felt much better, and after reading the county papers, he got up for his moments. Just after returning to his bed he breathed a deep sigh and his spirit took its flight as quietly and as peacefully as if he were to go to sleep. The deceased was born in Caroline county but removed to Kent many years ago, and engaged in farming on what is known as the "Home Farm," near Chestertown. By close attention to business and that keen business foresight and discernment which enables men to amass wealth, he accumulated some of the best landed estates in this and adjoining counties, to which he devoted the best energies of his life. Mr. Jarrell was a frugal man, but far from parsimonious. He helped others while helping himself, and in his business contact with his fellowmen he gave every man his due, and yet never lost a cent. He was a man of few words, but his few words were to the point, and he was indeed a most lovable character. During the years of our acquaintance, we learned to admire him for his fine business ability, for his gentle disposition and for the warmth and glow of his genial conversation. He was one of the most charitable men in the community, and the beauty of his charity was its lack of ostentation. He lived the principles of the Christian religion in his daily walk and conversation, and when the time for his departure arrived, he was able by the force of a strong character and an implicit confidence and faith in God to say "I am ready." With his departure a void has been made in our social life that always follows the passing of a good man, and while the world may be better for the life of a man like William E. Jarrell, yet we can ill afford to lose such a man from a community where his influence has been so strongly felt for good. Mr. Jarrell was one of the organizers of the Chesterville Southern Methodist Church and for years prior to his death he was a most liberal contributor to and ardent supporter of its interests. He left a large landed estate, a monument to his industry and wise business methods, but above all he leaves to his family an additional heritage the glow of an upright Christian life, spent in deeds of kindness and helpfulness to his fellow-men. He is survived by a widow, who was before marriage a Miss Clements. She has been who for 10 years has been a most devoted helpmate, sharing his trials and joys, and throughout all his illness ministering unto him with a devotion that will be remembered. He also leaves one son, Mr. W. Frank Jarrell, who has assisted the father in business, cared for him lovingly in sickness, and has been a dutiful and faithful son. He also leaves four brothers, Messrs. Joshua, of near Kennedyville; Robert, Wesley, and Charles Jarrell, of Caroline county, impressive funeral services were held at the residence on Tuesday at 12 o'clock, conducted by Rev. Dr. Rood, of Chesterville, M. E. Church, South, assisted by Revs. Drs. F. T. Barrett, of Chestertown, and Rev. A. P. Prettyman, of Galena. A great concourse of sympathetic friends and relatives attended the services. The remains were interred in the cemetery of Messrs. E. A. Hurlock, Messrs. Fred. G. Usilton and Thomas D. Bowers sang favorite hymns. The pall-bearers were his four brothers, his brother-in-law, Mr. Alday Clements, and Mr. James Brice. Interment was private in Chester Cemetery. The floral tributes were profuse and beautiful. Undertaker J. E. Ferguson had charge of the funeral arrangements.

They're After You, Mr. Guest.

The following clipping was taken from the New York Mail in reference to the oldest horse in America, based upon a recent account of the animal in the Baltimore American from Chestertown, Md., owns a horse which is one of the oldest, if not the very oldest, creature of his species in America. The animal celebrated the forty-first anniversary of his birth on May 6 by cavorting joyously around in a beautiful pasture and performing a few unstudied stunts in high kicking that a yearling colt might have envied. On the day that Samuel J. Tilden was nominated for president, in 1876, this horse, a big, sleek sorrel, then called Stonewall, was driven to a town 25 miles away, where his owner, a great admirer of the Democratic nominee, changed Stonewall's name to Samuel J. Tilden in honor of his party candidate, and under that name he is still living in ease and comfort. "But there have been, and possibly still are, older horses than this Maryland veteran. At the horse show here in New York three or four years ago there was exhibited a horse once used in the street car service that was said to be 45 years old. Perhaps some reader knows one still more aged. If so, his record would be gladly received at 'The Office Window.'

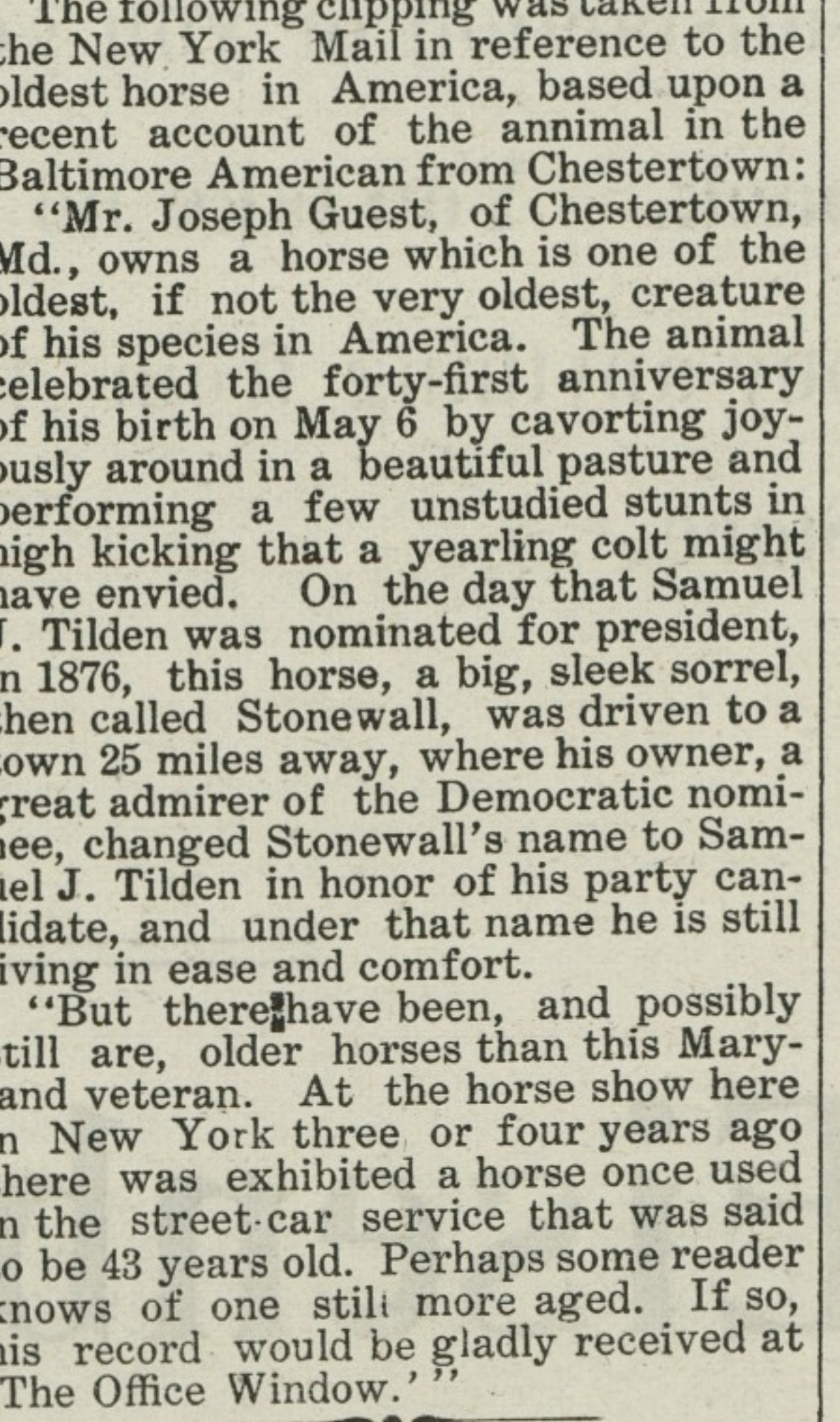
SPEED PROGRAMME.
