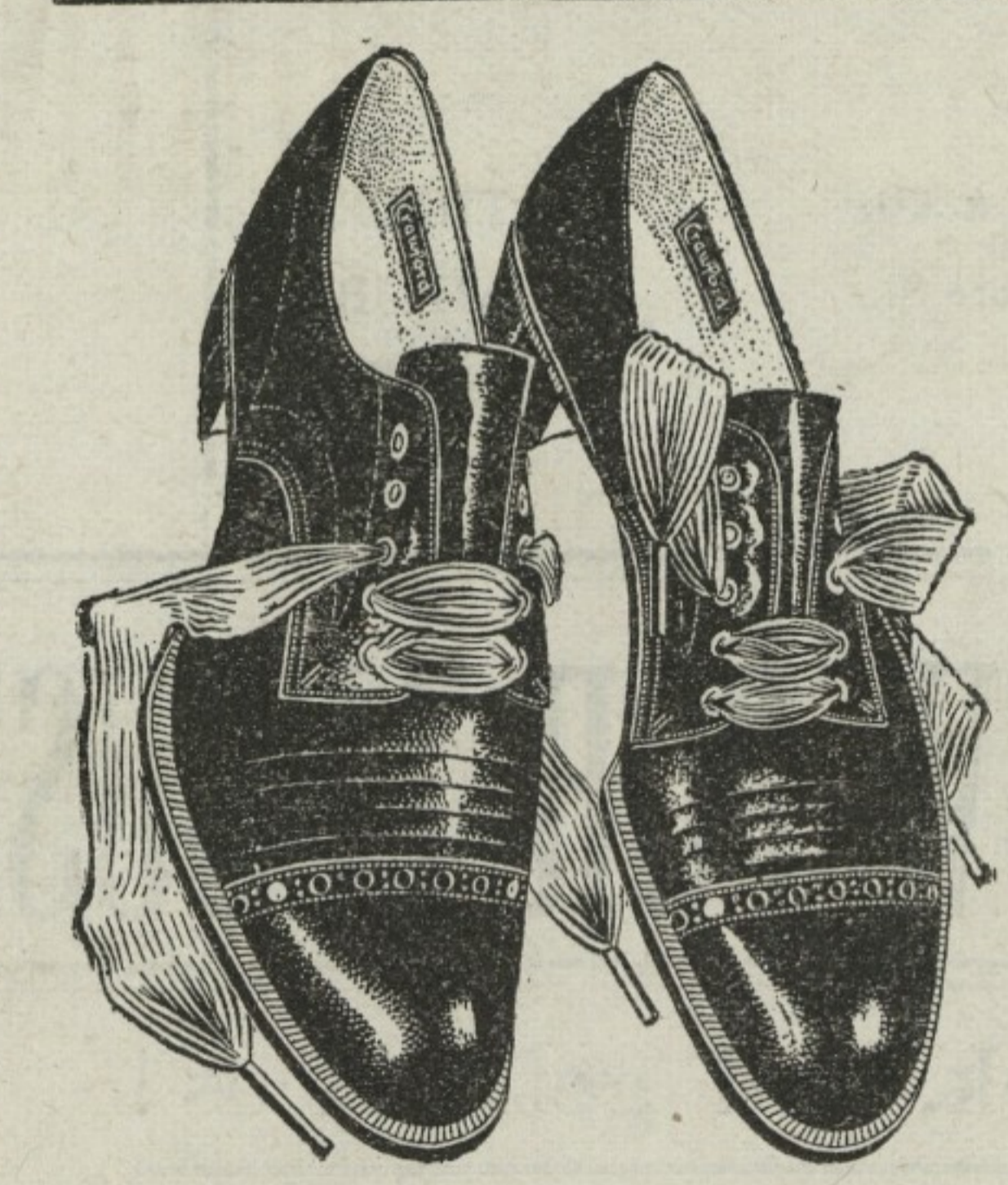

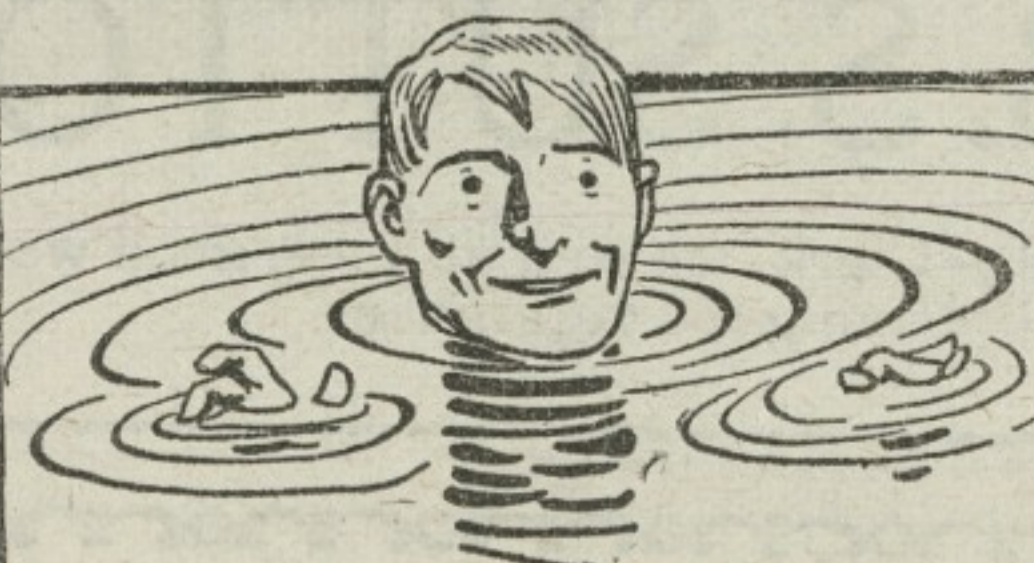

Secretary Appointed.—Superintendent of Schools Milton Melvin has appointed Miss Mildred Davis, a graduate of the Commercial Department of the Chestertown High School, as his private secretary. Miss Davis was highly recommended for the position and will fill the bill, we are quite sure.

State Camp to Meet in Elkton.—Arrangements have been made to hold the annual meeting of the State Camp, Patriotic Order Sons of America, in Elkton, on August 9 and 10. The members of the Elkton Camp are making great preparations to entertain royally the 200 and more delegates from various parts of the state.

Sunday School Picnic.—Emmanuel P. E. Church Sunday School will hold its picnic on Thursday next, August 4, at Colchester. Conveyances will leave the parish building. The hour of leaving will be announced at the Sunday services. The notice on page 3 under church notes, giving the picnic as Wednesday is an error, the picnic will be on Thursday and not on Wednesday.

Preacher Robbed.—Burglars entered the home of Rev. Dr. J. M. Gill, in Seattle, Wash. State, one evening last week while the pastor was absent, and stole from the church and stole more than \$500 worth of jewelry. Trunks were broken open and their contents scattered about the house. Among the lost was a diamond stud, three watches, a pearl and diamond stickpin and two medals, gold cuff buttons and a revolver. Some of the articles stolen were heirlooms that had an interest to Dr. Gill above money value.

Boil Your Drinking Water.—This is the season of the year when typhoid germs are lurking around, and we advise the boiling of all drinking water both in the town and county, as a preventive from that source. We also advise our dairymen to make frequent analysis of their milk, and all housekeepers to keep their houses as free of the dangerous germs as possible. To our minds it is the house-tying that is more to be feared than anything else in the spread of disease, and we advise everybody to be as careful as possible in these extremely warm days.

Boat Damaged by Fire.—Mr. Louis K. Stam's fine speed launch was badly wrecked by fire on Wednesday afternoon while off the mouth of Chester river. The top of the boat was burned, but the hull and engine may be saved. Mr. Stam was picked up by Mr. Whalen and towed to Rock Hall, from where he telephoned the accident. This is the fastest boat in these waters and it is fortunate that she was not destroyed. She caught fire from the ignition of the gasoline. Mr. Stam had a most thrilling experience. He says several boats stood off in the distance and watched him fight the flames, but not one came near to offer help except Mr. Whalen.

—Mr. A. L. Sparks has not rented Mr. R. Groomer Park's residence on High street, now occupied by Mr. James Dunbracco. It is still for rent.

—Mr. Joseph Downey, of Rock Hall, has been awarded the contract to build a fine hall 40x80 feet for the J. O. U. A. M. of Rock Hall. Work will begin at once.

—The home of Mr. Samuel Hicks, on Washington avenue, has been improved by an attractive coat of paint from the brushes of Mr. Prince and workmen during the week.

—Mr. John Bell, one of our most successful truckers and fruit growers will please accept our thanks for an "organizational" head of cabbage and a quantity of luscious peaches.

—Mr. Edward C. Walters, of near Galena, was appointed clerk to the board of assessors by the county commissioners on Tuesday in the place of Mr. Thomas C. Roe, who could not find it convenient to accept.

—Hansen Horsey, of Galena, the youngest pitcher of the Reading Tri-State League pitching staff, pitched the greatest game of his career on Tuesday, August 23, at the home of the Williamsport team, and allowing only four hits.

—Real Estate Broker George E. Lambert has sold for Mr. Rumsey Anthony to Mr. C. N. Sappington, of Baltimore, 17 acres of land along the river near Queen Annes, and Mr. Sappington is erecting a fine bungalow on a beautiful sight.

—A gentleman who is taking a great deal of interest in banking matters states that a certain gentleman on Thursday evening that he is authorized to sell from 1 to 50 shares of stock of one of the banks here at \$31 per share. Looks like money to me.

—County Commissioner T. Benj. Crew is a lucky man again this year. He will have 7,000 or 8,000 baskets of fine peaches just as he had last year. He has been selling his early peaches to Philadelphia this week and getting 70 cents per basket for them.

—It is currently reported that Mr. Eben F. Perkins, teller of the Third National Bank, is to be appointed cashier of the People's Bank recently organized. The Transcript reported this probable appointment last week. It is not known who the teller of the new bank will be.

At a meeting of the stockholders of the Chestertown Bank of Maryland on Wednesday last, it was decided to increase the capital stock of the bank from \$25,000 to \$30,000. This was done to enable the people interested in the bank at Galena to obtain stock in the Chestertown Bank.

—The farm in Broad Neck, owned by Mrs. Lydia Northam and advertised in the Transcript by Wm. W. Beck, at that time, was withdrawn on a bid of \$7200. The farm contains 196 acres of good land and may be purchased at private sale by Mr. Beck. The 1000 lots at the head of town, advertised in the Transcript by Messrs. Beck & Ivens, were also withdrawn on insufficient bids.

—Mr. J. D. Beachus bought the Usilton lot on Connon street for \$425.

An Unjust Rule.

The rule which the Diamond State Telephone Company put in force in the town and county last Monday morning requires that subscribers to the company give the number of a subscriber every time he wants to talk, and besides when the number has to be searched for in a book that contains most every town in Maryland and the peninsula before you can find Chestertown, the annoyance is all the greater. Conditions in the cities are different from those in rural communities, and the business of the Chestertown office is not so large, we believe, as to make an arbitrary ruling of this sort at all necessary. It has occasioned serious complaints from subscribers during the week, and we trust the company will rescind the rule.

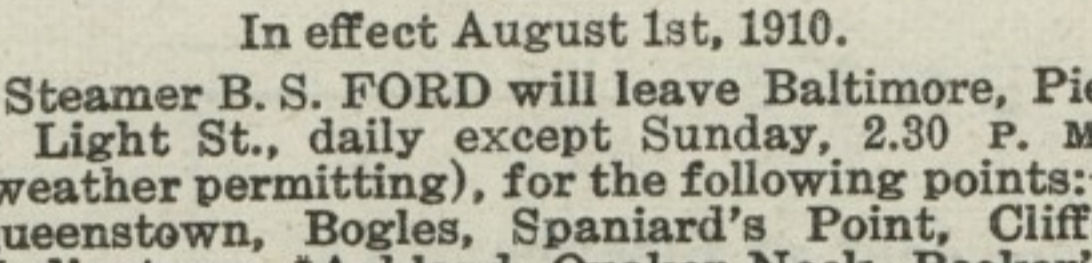
