SENATOR SMITH HAS OPPOSITION AT HOME.

On Thursday afternoon of last week delegates from the Republican, Progressive, Prohibition and Independent Democratic parties met in the office of William G. Kerbin, at Snow Hill, and organized a People's party, in opposition to the Democratic party of Worcester county. All of the above four factions held separate meetings and all agreed to organize a party in opposition to the Democratic party. Each faction named a delegation of three as a campaign steering committee, and these 12 men met in Mr. Kerbin's office and organized the People's party. The political conditions in Worcester county, it is claimed, have become so corrupt that such a move on the part of the people has become necessary. Money and trickery are declared to be the most potent factors of the Democratic party in the county. In the fall a full People's ticket will be put in the field. The new party will establish headquarters in Snow Hill. From now until the election a campaign will be prosecuted all over the county.

OUR DEATH RECORD.

MISS HARRIET M. SUDLER. Miss Harriett Malvina Sudler died Wednesday last at the home of her nephew, Emory Sudler, 2100 St. Paul street. She was born at Radcliffe Cross, Kent county, Md., in 1837, and was the daughter of Emory and Elizabeth Worrell Sudler, who was a daughter of Judge Thomas Worrell. Miss Sudler became associated with the Church Home and Infirmary in 1876 in a subordinate capacity, but in a few years became its matron. Under her care and management that institution grew to its present size and importance. She retired from the home in 1906. She is survived by a sister, Mrs. Anna Gordon Volk, of Washington, D. C., her brother, John Emory Sudler, having died in 1901.

MR. JOHN W. LUKE. Mr. John W. Luke died at the home of his daughter, Mrs. A. H. Suplee, at Betterson on Monday afternoon of general debility, aged 80 years and six months. Funeral services were held from his late home on Friday morning at ten o'clock, the Rev. Mr. Shaffer, of Shrewsbury, officiating. Undertaker W. H. Krusen in charge. Interment was in Still Pond cemetery.

HON. CHARLES F. WARWICK. Messrs. Eben F. and Thos W. Perkins attended the funeral of their uncle, Hon. Charles F. Warwick, former mayor of Philadelphia, on Monday. Mr. Warwick died Friday last after a lingering illness.

FORESTRY.

Reported for the Transcript by a Member of the Senior Class of the Chestertown High School.

Last week our State Superintendent of Forestry and the assistant superintendent paid us a visit, and gave us a very interesting talk, of which I will try to give a brief sketch.

The question concerning forestry is very important. Our trees are continually being destroyed and not being replaced. If this keeps up the forests will soon be exhausted.

We cannot do without wood. True it is, that many things are used in place of wood, but the time will never come when we can begin to do without this necessary material.

Look around us. See the many things that are made of wood. Is this not a good proof of its usefulness?

Another thing—our forests hinder floods. Were it not for the tangled mass of woodland debris, which absorbs the surplus amount of water, much of our country would become a flood plain.

By forming a sort of shield, forests keep great tornadoes from doing more damage than they do. Thus have mentioned a few of the many uses of forests.

Forest fires are becoming sources of much distress. These fires are caused by sparks that fly from trains as they pass through. Occasionally one will hear of a fire being started by a person, but only a very few are heartless enough to do such a dreadful thing.

Sometimes forests will burn for days and days, miles and miles without any one seeing the fire. These fires are caused not only by the growth of trees, but the small seedlings and sprouts which are hidden under the dense mould as well.

When fire kills part of a tree, it is quite difficult to dispose of them, as no remedy for the disease caused by them has been found as yet.

Many other diseases are befalling our trees, such as the chestnut blight, etc. With all these diseases and fires the forests will soon be exhausted unless something is done.

In his great speech at Salisbury on Saturday, Mr. Marbury gave Senator Smith a heavy jab in the following striking language: "Senator Smith boasts of his party's regularity. TAKES UP PAMPHLET. "I notice that in the pamphlet which the Senator's friends around here are circulating against me it is contended that I should not be elected to the Senate because at one time I opposed Mr. Bryan. But Judson Harmon also opposed Mr. Bryan at the same time I did and yet Senator Smith supported Judge Harmon for the nomination for the Presidency and carried his own county of Worcester for him last spring."

"But think you will find that Mr. Bryan and his friends would rather see elected to the Senate a man who, acting according to his honest convictions on these things he has the test of Democracy, I yield the palm to Senator Smith."

"If you don't think so ask Mr. Bryan. I will take the risk of his giving an unfavorable answer. If he does, I will withdraw my candidacy this instant. For Mr. Bryan is part, and a great part, of the Wilson administration, and I have something better to do than attempting to fight the Wilson administration or any part of that administration in this campaign. I will leave that task to Senator Smith."

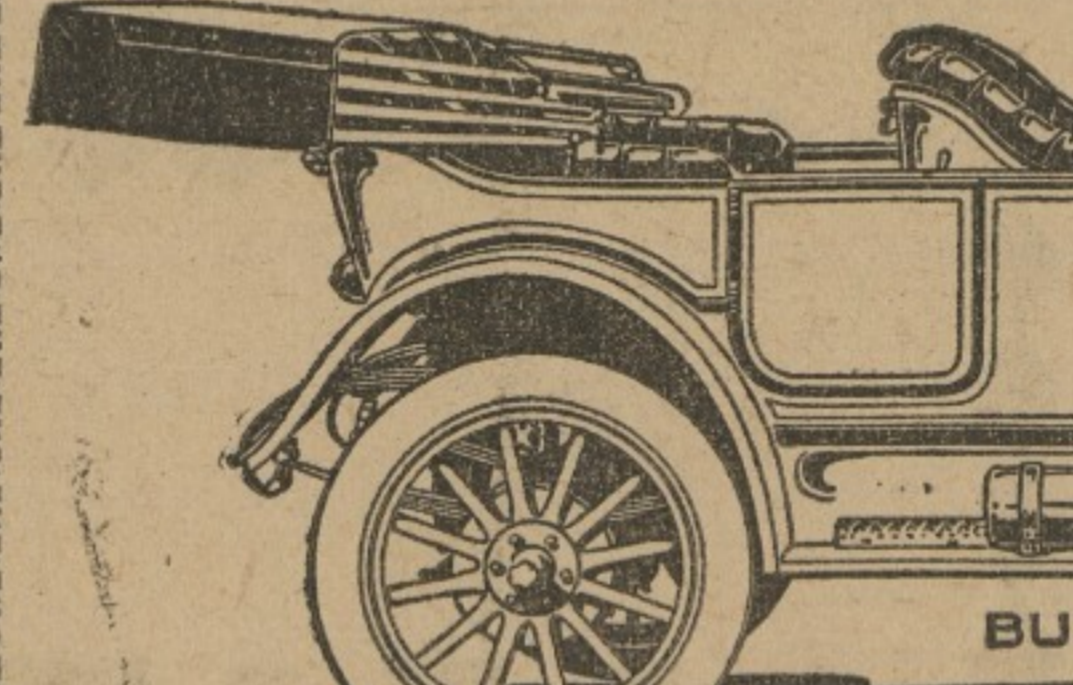

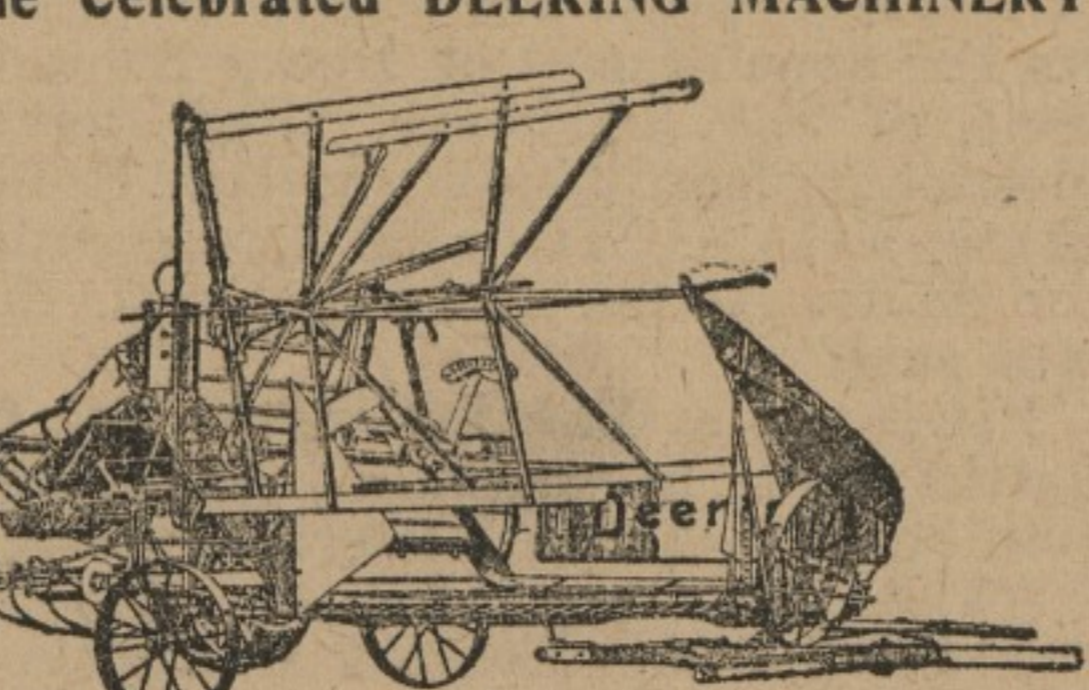

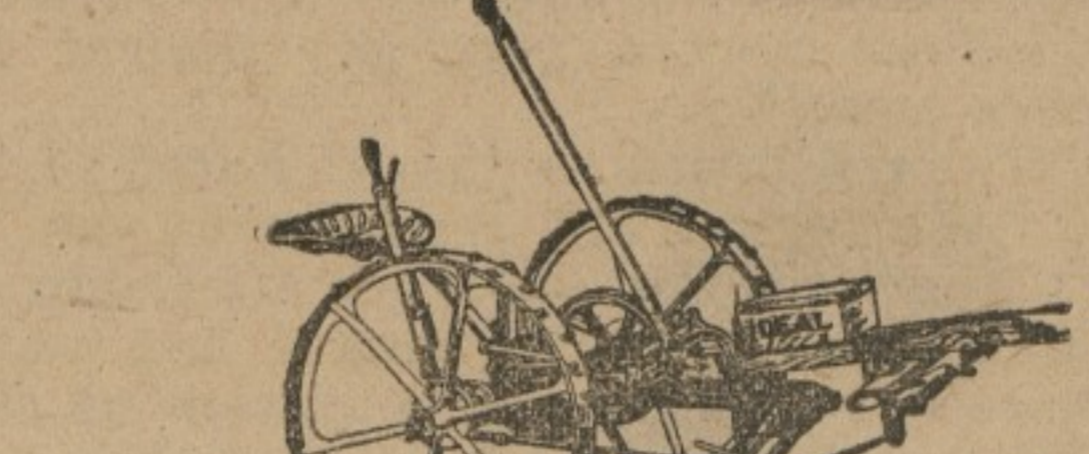
