FORMER Attorney-General Isaac Lobe Straus has committed political Hari Kar.

DON'T forget, Mr. Tax-payer, that the one great cry of the Organization is for MORE MONEY.

The indebtedness of Kent county under the Organization control is \$110,000. Under the Antis it was \$37,000. Is that not enough to make the people know to vote in the coming primaries?

KENT COUNTY was partially if not actually bankrupt under Organization management. Why, then, should the management of the Democratic party be handed over to the Organization by the election of their candidates for the State Central Committee?

IN VIEW of the fact that none of the gentlemen who were called upon two weeks ago to furnish evidence against the Democracy of the Kent News have responded, the public is satisfied that the TRANSCRIPT's charges are correct. If they had not been the Kent News columns would have been full of letters last week. We shall bring other witnesses to light before long.

SENATOR SMITH has signified his intention not to oppose the appointment of Col. Serlock Swann as postmaster at Baltimore, and the appointment will be confirmed. Mr. Grant had been promised by the Organization workers in his district their support for the Legislature, but the Chestertown leaders turned him down for Mr. R. A. Shallock. And now Mr. Grant and his friends are wondering with the rest of us, how much sincerity there is in Organization promises.

THROUGHOUT the State there is a determination on the part of the people to put the old political Organizations out of power. The latest development is in Anne Arundel county, where an Anti-Organization or Progressive Democratic movement of formidable proportions has been organized to fight the Organization under the leadership of Dr. George Wells. There is a similar movement in Wicomico county, and Cecil county got into the game last year. And so Kent is not the only county where the people are up against the Organization.

AT LAST CONVINCED. The publication of an eight-column paid advertisement by Isaac Lobe Straus in the Baltimore American on Saturday, just after the dinner at the Belvedere Hotel by Mr. Charles H. Grasty, editor of the Sun, in honor of Secretary of State William Jennings Bryan, is an acknowledgment that Mr. Straus and the friends of Senator Smith are at last convinced that not only is President Wilson interested in the Maryland Senatorial situation, but that Mr. Bryan is also concerned for the welfare of the people of the State. It looks as though some one else has been guilty of misrepresentation, and all the former paid advertisements by Mr. Straus are losing whatever effect they may have had.

The President also succeeded in pouring oil on the troubled waters in California through his Secretary of State, Hon. William Jennings Bryan. And now if the President shall deem it necessary to assist the people of Maryland in electing Democrats to the United States Senate, who are in thorough accord with his policies and principles, we advise Senator Smith and the Kent News to seek shelter, for he will come as a conqueror, just as he went to Jersey. And he'll do it, because he is determined that the people of this country shall enjoy their rights so long as he is their servant.

MR. STRAUS INCONSISTENT.

When Mr. Straus announced his candidacy for the United States Senate for the long term, he not only attacked the record of Senator Smith in the most scathing manner, and stated that Smith's re-election to the Senate would be a PUBLIC CALAMITY, but he claimed that he is in thorough accord with the principles and policies of President Wilson. And yet, when President Wilson intimates that he wants the people of Maryland to send to the Senate a man who is in accord with his principles and policies, Mr. Straus repudiates the President and delivers a scathing attack upon the President in an eight-column advertisement in a Republican newspaper. This position is about as consistent as is the attitude of Mr. Straus towards the candidacy of Mr. Marbury. A few days prior to Mr. Marbury's announcement of his candidacy for the Senate, Mr. Straus told Mr. Marbury if he would run that he (Mr. Straus) would get out of the fight, and that he would do everything he could to help elect Mr. Marbury, and yet, almost the very day after Mr. Marbury announced his candidacy, Mr. Straus attacked Mr. Marbury's Democracy in a paid advertisement in all the Baltimore city and many of the county papers, and since that time Mr. Straus has been furnishing editorial matter for a number of county papers attacking Mr. Marbury's Democracy. We submit that such a position is a very unenviable one for a man who professes to be a Progressive Democrat to occupy, and is a most inconsistent position, to say the least.
