New Private Secretary.—Mr. H. H. Sasser III, who has served as private secretary to President James W. Cain very acceptably for the past two years, has resigned to take up the study of law at the Maryland University in the fall.

Will of Late Joshua McCleary.—The will of the late Joshua McCleary was filed for probate in the Orphans' Court on Tuesday. He leaves his farm of 88 1/2 acres, situated near Tolchester, together with all the rest and residue of his estate, personal and real, to his wife, her heirs, etc.

Personality of Late Alday Clements.—The appraisers, Messrs. Philip G. Wilmer and John H. Cleland, of the personal estate of the late Alday Clements, filed an inventory with the Orphans' Court on Tuesday. The inventory shows an appraisal of the stock, farm implements and grain on his seven farms at \$42,320.50, and stocks and securities are appraised at \$31,314.54, making a total appraisal of personality of \$73,635.04.

Betterton-Still Pond Road. The Board of County Commissioners on Tuesday opened the bids for the construction of the new road from Betterton to Still Pond station. There were two bids, the lowest of which was \$7,500 per mile, making the total cost of the 14 1/2 miles considerably over \$200,000. The commissioners immediately telephoned to Mr. W. B. Miller, of the State Road Commission, in Salisbury, and asked him to meet them at their office in Chestertown on Thursday evening, which Mr. Miller very kindly did. The situation was thoroughly canvassed and Mr. Miller assured the commissioners that he could secure a competent engineer who would build a most satisfactory road at \$5,000, and arrangements were at once made. Mr. Miller stated by word of mouth that the cost of the road would not exceed \$21,000, and that work would begin sometime the latter part of this month.

A TIE ELECTION.

Warm Contest for Town Commissioner in Betterton Ends in Tie Vote for Candidates.

Never before in the history of town elections in this county has such a condition arisen as occurred in the election at Betterton on Saturday afternoon last, when Mr. Arthur P. Emerson and Col. A. H. Staples fought each other to a standstill in the polls. Sixty-four votes were polled and each candidate received 32 votes. There were a number of tax-payers away from home at the time, and Staples failed to vote. Just what arrangement will be made to settle the question has not been decided. There is nothing in the town charter providing for an adjustment of a tie vote, nor is any authority given the Board of Commissioners to act in the matter unless there be a vacancy.

Capt. John Brice is the retiring commissioner, and he holds office until his successor is elected and qualified. The opinion among our lawyers is that another election will be necessary to settle the matter, and in a conversation with Mr. Emerson, who was in Chestertown on Monday, he stated that he will demand another election.
