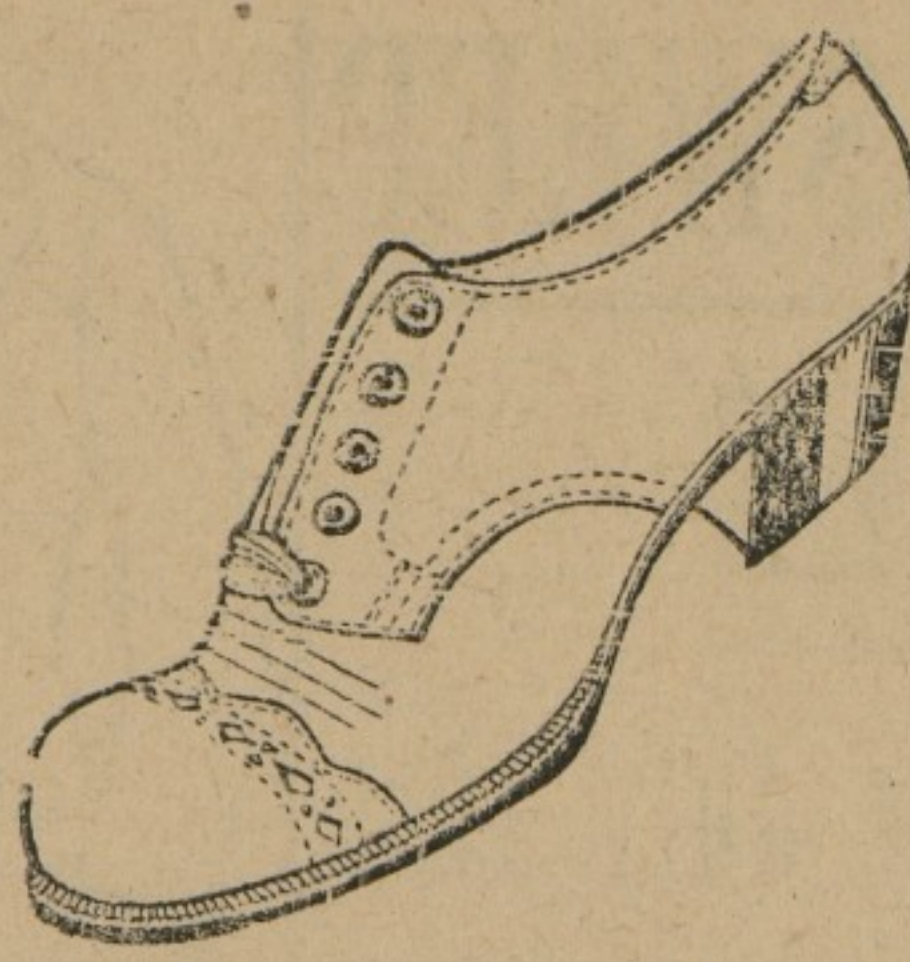

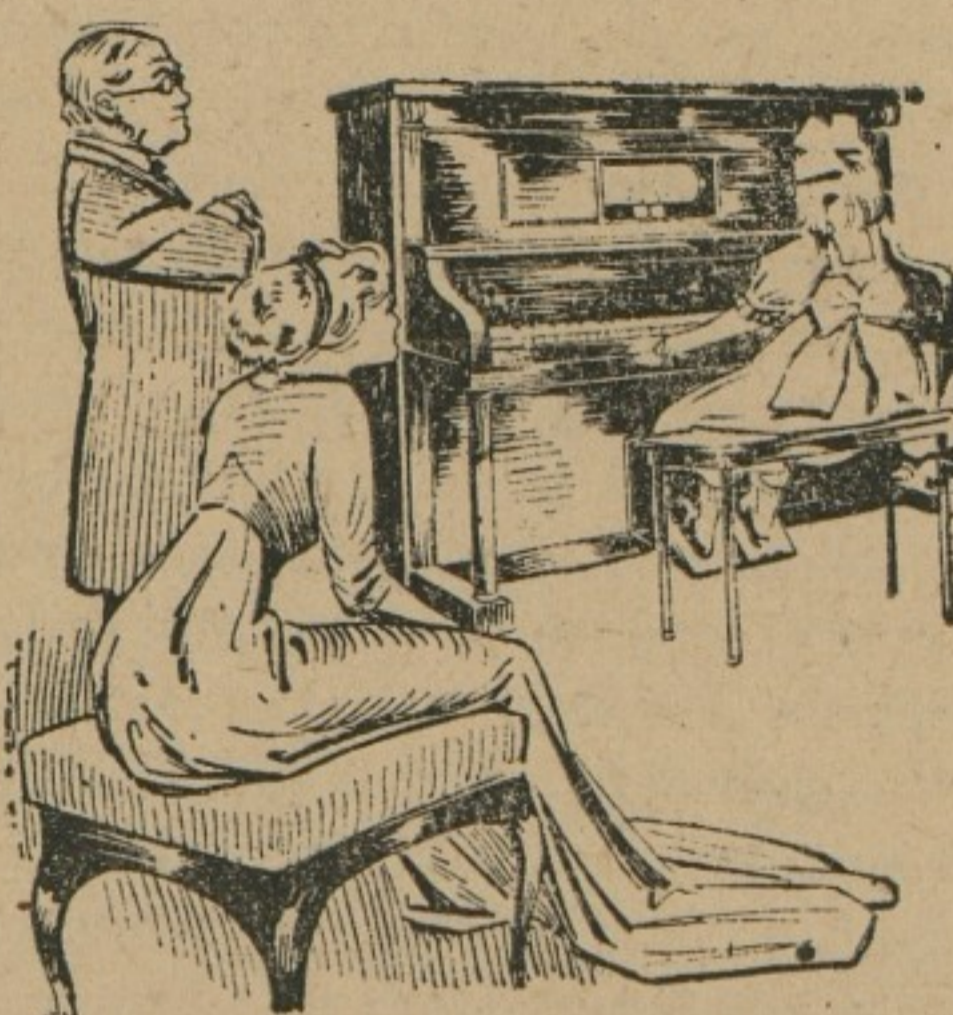

LOCAL MATTERS

Cause of Bank Failure.—The 2nd National Bank of Pittsburgh, Pa., closed its doors several days ago, likely to be a far-reaching affair. It had widely advertised for funds and paid or rather promised to pay its depositors 4 per cent. J. B. Ramsey, ex-examiner and ex-President of the Mechanics' Bank of Baltimore, commenting on the failure in Thursday's Sun says the bank paid too high rate of interest for their money. We have not heard of any one here caught in the failure, being lured by the unsafe rate of 4 per cent.

A Fine Issue.—The last issue of the Collegian, just issued from the presses of the TRANSCRIPT, is one of the most interesting ever gotten out by the college students. No Poultry Exhibit.—Those interested in having an exhibit of poultry at the fair in August regret the cost in arranging an exhibit it will be best to defer the exhibition until next year. It was estimated that it will cost from \$150 to \$200 to arrange for a creditable exhibit, and there were but \$75 available. An appeal was made to the fair management, but their outlay of money the first year of their existence has been so heavy that they could do nothing more than provide the place for the exhibit and contribute a small sum for expenses. The poultry raisers therefore decided to organize a poultry association early in September, and get in readiness to hold an exhibit at the next year meeting, and the association must come to their rescue.

Race Horses Reported Sold.—Mr. John Toy, of Philadelphia, the well-known turfman, and a friend from Delaware, it is reported, has purchased from Mr. Harry Daley, of Maryland, the fast pacer Belton K, that lowered the Radcliffe Park track record on the Fourth from 2:14 to 2:12. The price paid for him is said to have been \$500, with the stable and racing paraphernalia included. It is also reported that the same gentleman has purchased Pony Boy for \$1,000, but there is some uncertainty about the latter sale owing to the fact that Mr. Rising stated on the Fourth to Mr. Toy that he would sell Pony Boy if he did not go on the northern circuits to race. Mr. Rising expects to leave next week for the racing circuit and he wants to take the Boy with him. These are two of the fastest horses on the Maryland-Delaware Peninsula and the man that owns the money for them will get two bread winners. The option on Pony Boy expires to-day. Mr. Powell Pescock, the well-known Middletown trainer, will have charge of both horses.

Hard to Get Whiskey Now.

The Webb bill, which was passed by Congress whereby it makes it unlawful to ship spirituous liquors from one State into another, or from one part of a State which is wet into a county where prohibition exists, went into effect on Tuesday, July 1. This being the fact, it will be unlawful in the future for whiskey to be shipped into Kent county from Baltimore or Wilmington or any city or town. The operation of the law, however, has had no appreciable effect in diminishing the number of packages of liquor coming to Chestertown daily by express.—Enterprise. The enforcement of this law is the duty of State officers, and they should seek diligently to enforce all laws.
