SENATOR SMITH MADE A MISTAKE.

In commenting upon the result of the election in Worcester County, the Wilmington Evening of Monday said:

"The curious contest over the State Senatorship in Worcester county, Maryland, growing out of last Tuesday's election, shows how United States Senator Walter Smith made a great political mistake."

"Senator Smith is the Democratic boss of the county. According to newspaper stories that are uncontroverted, he became alarmed at the proposed nomination of Orlando Harrison of Berlin for the State Senate by the Fusion forces. To stop it, he forced the nomination of Harrison as the Democratic candidate against the protest of many leading Democrats, and Harrison accepted."

"But the Democrats resented this arbitrary action by Senator Smith. They opposed the election of Harrison, and in the face of a 1,200 majority for Blair Lee for United States Senator, Harrison was defeated by four votes, but the rejection of one district leaves him a winner by the decision of the Board of Canvassers. The Republican candidate of that district first refused to sign the returns, believing they were thereby helping Harrison, but when they learned that the vote of the district would be cast for the Fusion candidate, they insisted upon signing. It was too late, however, and the board declared the returns illegal, eliminating them from the count. The contest will go to the courts, and probably to the State Senate."

"Had Senator Smith not given way to fright and allowed the Democrats to name their own candidate for State Senator, a clear and undisputed victory might have been the result. Now the final ending is in doubt and Senator Smith is politically discredited in his home county."

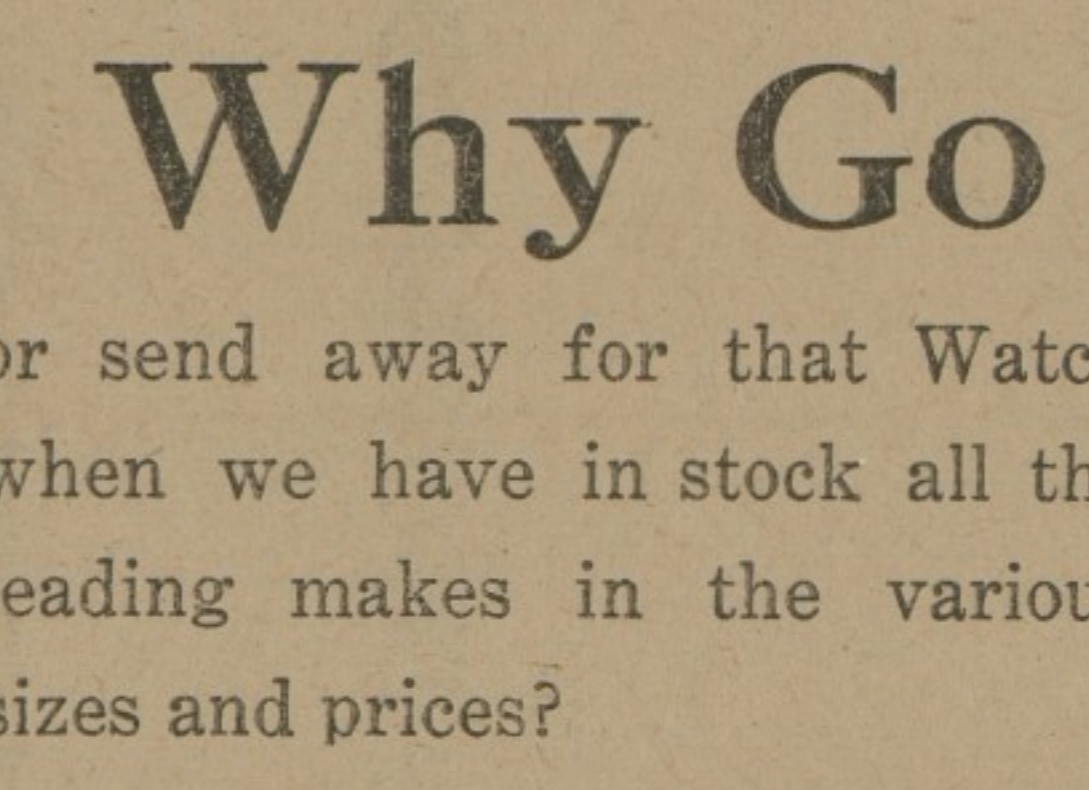
