PRESIDENT H. J. PATTERSON has tendered his resignation to the Board of Trustees of Maryland Agricultural College to take effect July 1, 1915, in order that a commission form of government for the college may be established. This is a suggestion from Prof. Patterson himself.

CONGRESS may adjourn next week if the law-makers can satisfy the cotton belt with legislation that will aid the cotton growers of the south.

MR. VOTER, when you go to the polls to cast your ballot on November 3rd, remember that you must mark your ballot TWICE for Jesse D. Price for Congress. Senator Price is a candidate for both the LONG and SHORT terms, and that is the reason you must vote TWICE for Price. Now remember that, Mr. Voter.

Now that the registration is out of the way, the State Central Committee should organize each precinct and district in the county for effective work in getting the voters to the polls in November. Every negro voter in Kent county will go to the polls and vote on November 3rd, and the longer the Democrats of the county fail to do their duty as citizens and exercise the right of franchise, the greater will become the danger of negro domination in the politics of the State, and the less reliable will be the quality of labor. If the Democrats think they have a walkover in this contest they are sadly mistaken. The Republicans are going to put up a hard fight to elect Bob Dyer to Congress, as well as for Carrington for United States Senator, and the State Central Committee should get busy and keep busy from now until the day after election.

FOR BETTER MAIL SERVICE. Now that a quick automobile schedule between Chestertown and Centerville, and Easton has been established by Mr. Wm. H. Waddell and his son, Randolph, which route connects on schedule time with a similar route operated by Mr. P. E. Cordan between Easton, Cambridge, Hurlock and Salisbury, it would be a capital idea if the banking, legal and business interests of this town should endeavor to divert Eastern Shore mail service to this route. Such a scheme would secure quicker mail service than we now enjoy between these towns, especially in the afternoon, and we see no reason why such a service cannot be established. This is a novel idea, yet it is a meritorious one, and since we are living in a progressive age, such a plan is thoroughly in harmony with the spirit of progress. Let Mr. Waddell and the business interests of the town and Shore push this matter.

TO VOTE SEPARATELY. Voters at the coming election will not only have the pleasure of voting for a Congressman and United States Senator, but it will be their privilege also to vote a separate ballot for or against the SCHOOL HOUSE BONDS. Separate ballots and ballot boxes have been provided for the bond issue votes, and no tax-payer in the county should fail to vote his ballot on the bond issue. This is an exceedingly important matter to the tax-payers at this time of increasing county expenses and an ever-increasing State tax rate, as well as a more than probable increase in the town tax rate in 1915. These bond issues call for the expenditure of more than \$70,000 of the tax-payers' money, with interest added to date of maturity, as well as other expenses attached to said bond issue. Beginning with 1915, \$1,000 plus the interest on the entire bond issue, is to be added to the county expenses every year for the next 70 years and more, and this added expense, together with other expenses being heaped upon the tax-payers by Organization representatives in the legislature from time to time, will mean forever an increasing tax burden unless the people do something to put a stop to the absolute waste of the tax-payers' money. We urge our tax-payers to remember their duty when they go to vote in November. DO NOT FAIL TO VOTE YOUR SENTIMENTS ON THIS

SCHOOL HOUSE BOND ISSUE. If you think these fine school buildings are needed in Kent county, which spends more money for schools every year than any other county on the Eastern Shore of approximate taxable base, vote for the bond issue. It is up to the tax-payers to do the rest.

Result of Registration.

The result of the recent registration in Kent county is very gratifying to the Democrats, the total affiliated vote showing an increase over the affiliated Republican vote of 805. It is also interesting to note that but nine voters registered as Prohibitionists, while there are 16 Bull Moozers, 6 Independents and 49 declined to give their party affiliation. The total affiliated Democratic vote is 2,504 as against 1,699 affiliated as Republicans, a majority of 805.

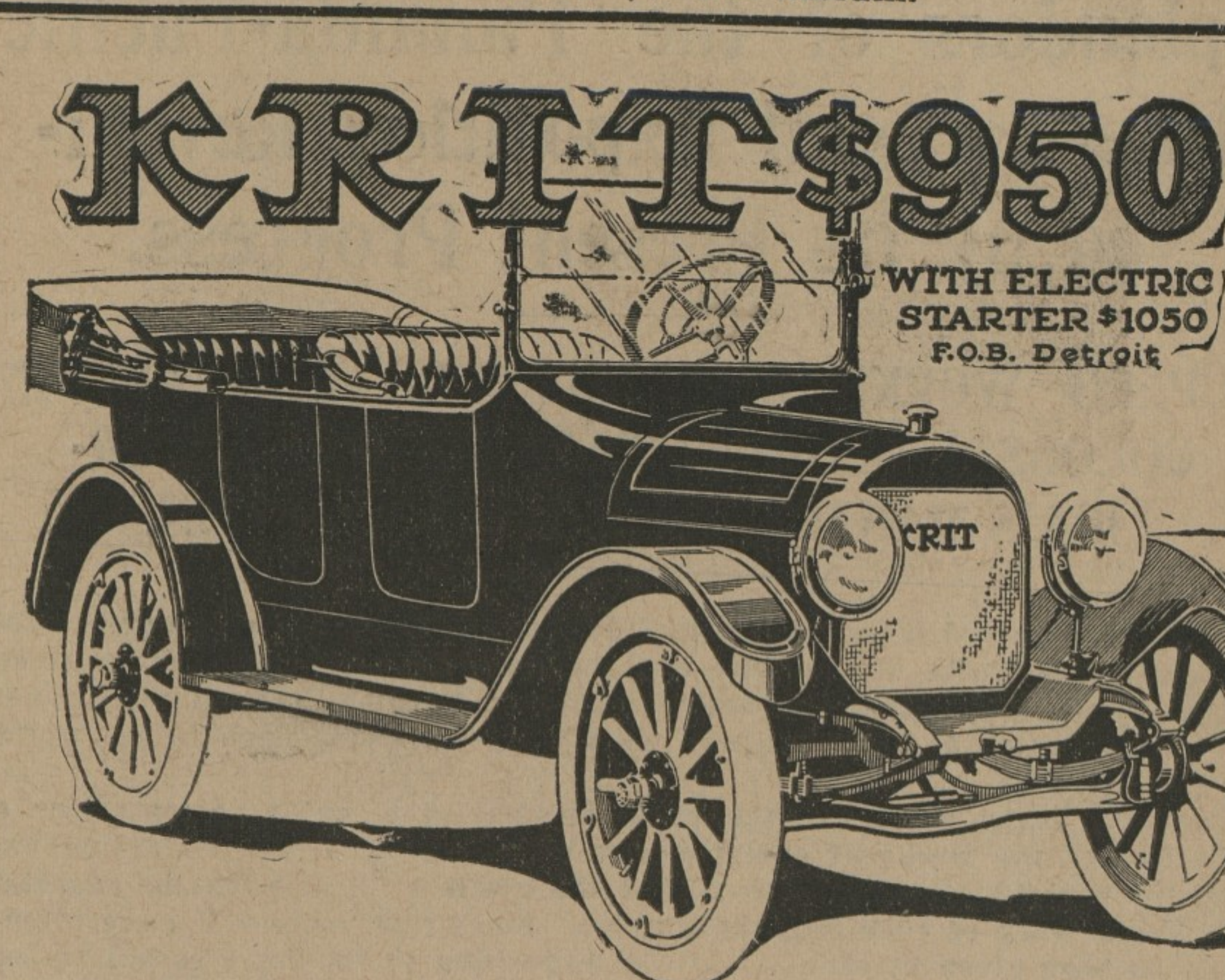
