MR. CHARLES JUDEPIND assumed charge of the Rock Hall postoffice this week, as did also Mr. Washington Finley Collins at Millington.

The appointment is made by the Governor. It is rumored that Mr. A. S. Crawford, an Organization Democrat, is to be appointed a justice of the peace here to succeed Col. Samuel L. Wright who has resigned.

EVERY farmer and stock dealer in Kent county should assist the State Live Stock Sanitary Board in its efforts to prevent an outbreak of the foot-and-mouth disease in this county. It has made its appearance in Caroline and Talbot counties, and the loss to the farmers in those counties has already been heavy.

THE ROCK HALL POSTOFFICE.

Mr. Joseph Ryan, the Rock Hall correspondent of the Kent News, delivered himself of a tirade last Saturday in reference to the naming of Mr. Charles Judepind as postmaster at Rock Hall to succeed Miss Hinson, who was appointed several months ago when the office was a fourth-class office. Of course Mr. Ryan's statement was made for whatever political effect it may have with the friends of Miss Hinson, who, with all the rest of us, regret that she has been a victim of circumstances. But to those who know the real truth of the circumstances of the case, Mr. Ryan's statement is simply amusing. Mr. Ryan must have known that the Organization forces were straining every nerve to oust Miss Hinson from the job as soon as they learned that the Rock Hall office would be raised to the third-class, thereby giving the President the power to name a new postmaster if he desired. And the truth of the matter is that the Organization leaders here in town were making a desperate effort to put Mr. Frank Wheatley in the postoffice at Rock Hall, although Mr. Sterling Jones' friends in Rock Hall received assurances that he would receive the endorsement of the leaders here. And we understand that Mr. Wheatley's friends were so confident that he would land the job that some of them had quietly congratulated him upon being the next postmaster at Rock Hall, but didn't say a word about it to Miss Hinson. When, therefore, President Wilson recognized his personal friends, Hope H. Barroll, Esq., and his son, L. W. Barroll, Esq., by appointing Mr. Charles Judepind, it so stunned the Organization forces in Chestertown and throughout the town of Rock Hall, that Mr. Joseph Ryan, the correspondent of the Kent News from Rock Hall, was the only man the whole county over, who had the courage to try to make political capital out of a game in which the Organization was a strong "player" and lost out. And mark you, the whole trouble with President Wilson now is, that he failed to give the Organization faction the postoffice appointments at Rock Hall, Chestertown and Millington, and as a consequence, he can never be elected President in this great big United States any more. What a pity for the country at large.

Mr. Barroll makes no charge for his services and if anyone desires to winter a German to do the chores about the place, we advise them to call on Mr. Barroll.

THE REPUBLICAN SCARE.

Now that the election is over, and the Republicans have failed in their effort to recover the House of Representatives and the State of Massachusetts, and there is no possibility of their making any change in the tariff, will they please cease their malign efforts to depress business or cause a panic.

For two years, ever since the Democrats carried the last national election, the Republicans have been trying to injure business. They met with no success for about a year. During all the time the country was waiting for a Democratic administration to take office, and during the discussions of the Underwood tariff, the business of the country continued to expand. Then the enforced economies of the railroads and the reduced purchases by foreign countries which were suffering from revolutions or business stagnation began to tell on trade. Last summer the country was beginning to emerge from the doubt and contraction due to railroad economies and restricted foreign buying, and then the European war broke out. Of course business was temporarily checked. At once the Republicans seized upon this as another terrible result of a Democratic administration, and there has been consistent and persistent malignant exaggeration of the degree to which business could not revive and that still worse times were in store for us.

Republican business men, who have admitted that their own business was better than ever before, have insisted that the fact must be conceded because of their political effect would be bad. Republican manufacturers whose business is always dull in the fall, and who had occasion this fall, as usual, to shut down for a time, or curtail their output, took pains to do it before the election for the sake of the effect it would have on the voting.

There are still directions in which the war has a depressing influence on our business, but there are others in which it is adding greatly to our trade. The West, with its high prices for the biggest wheat crop ever harvested, is booming. Factories East and West are rushing with orders from foreign governments. Exports are exceeding all records. Cotton is moving more freely. There is no excuse for insisting that the winter is going to be a very bad one. Men in the building trade are generally idle in the winter. In some other trades the war's interference with commerce will be a real illness and suffering.

But boot and shoe orders, orders for textiles, for food, for steel products, are keeping many of our mills and factories running over-time. Some more unexpected than usual is inevitable, but the probable amount is grossly exaggerated by Republicans, and it is all charged to the Democratic tariff.

Now that the Republicans have failed in their effort to capture every branch of Congress will they please stop their calamity croaking and give the business of the country a chance to pick up? Philadelphia Record.
