We understand that the ladies will ask for the use of the old pump house which they propose to improve and use for suppers, a rest room and other conveniences, and it is their intention to improve the ravine by planting choice flowers and shrubbery. This we are quite sure would be far better than simply to make a pasture lot of part of the ravine and allow the balance to grow up in weeds and marsh. There is an urgent demand in Chestertown for a suitable place in which to hold bazaars, suppers, etc., and this can be made a fine location. The ladies have taken hold of the matter, and the men had better fall in line, or something will fall.

PEOPLE'S COLUMN.

TO THE EDITORS OF THE TRANSCRIPT, GENTLEMEN: In my letter in your issue of Saturday, Nov. 13th, 1915, the request was made of Wm. B. Usilton, one of the editors of the Kent News, to meet James Ellwood Morris, who was the Anti candidate for the Senate in the primary in September last, together with Charles N. Satterfield, William B. Copper and Henry Brown at the office of William W. Beck, Esq. In that letter I requested Usilton to deny in a card in the Kent News, that he had ever made the statement, prior to the primary of Sept. 14th, 1915, to Charles N. Satterfield that James Ellwood Morris was nominated on the Anti ticket he, Usilton, would not support him. Four readers will observe there was no denial whatever in the Kent News of Saturday, November 20th. Nor was there any card published by Usilton putting himself straight before the people of the county.

By this he leaves all to infer, without any uncertainty, he could not with truth make such denial. There is no use starting anying unless you are prepared by word of mouth. That he was afraid to meet these gentlemen and make denial by word of mouth. There is no use starting anying unless you are prepared to end it. In order that the people of this county may know what this man Usilton is and what "Usiltonism" and the Kent News mean to the Democratic party I give the facts below:

Yesterday, Friday, November 19, 1915, Mr. Henry Brown came to my office while Mr. S. Scott Beck was present. Mr. Brown made the statement to Mr. Beck and myself that he had come in to meet the gentlemen named in your letter of Nov. 13th last at William W. Beck's office. To the statement then made to him that Mr. Morris was not accessible as he was in town, not asking when it would suit him to meet them, Mr. Brown instantly replied, "Right now, I want to do it right now. I will go in there at once and say what I know about it."

Mr. Wm. B. Copper was called up over the phone and at once agreed to come over. In the presence of Mr. Copper and Mr. Scott Beck, Mr. Brown repeated at length how Charles N. Satterfield had told him of Mr. Wm. B. Usilton's conversation in which Usilton said, "If Ellwood Morris is nominated on the Anti ticket I shall not support him." I then called Charles N. Satterfield over the phone and requested him to come around and meet these gentlemen in Mr. Wm. W. Beck's office. Satterfield replied that he was busy. I then asked him to come around a little later if he could do so. "No," he said, "I will be busy then."

"Well," I replied, "Can you come around in the morning?" He said "No," I then told Satterfield what Mr. Brown had said to me. He replied that Mr. Brown was mistaken. I answered Mr. Brown says he was not mistaken, that the day after your talk John C. Davis, your partner, called him over the phone, and in his absence requested his wife to tell him on his return not to mention what Satterfield had told him the day before, because it might cause hard feelings. Satterfield's refusal to meet these gentlemen is all the satisfaction he gave us as to his willingness to tell the truth or denounce a lie.

I immediately called up on the phone Wm. B. Usilton and asked him if he would be willing to meet these gentlemen in Mr. Wm. W. Beck's office. He replied, "No, he would not." I told him who were in my office. He still refused. Thereupon Wm. B. Copper, Henry Brown and myself went into Mr. Wm. W. Beck's office. Mr. Brown then made this statement, "Now, gentlemen, don't want to say anything at all that is unpleasant, but what occurred is this: Charles N. Satterfield told me before the Democratic primary that he had had a talk with Wm. B. Usilton and Usilton assured him if Ellwood Morris were nominated for the Senate by the Antis, that he, Usilton, would not support him in the election. The next day Mr. John C. Davis called up my house and talked with my wife as I was absent. He requested her to say to me not to mention the matter about which Satterfield had spoken the preceding day, that it would be better not to make it public, it might cause hard feelings. All I have to say is that I am perfectly willing to meet Mr. Usilton and Mr. Satterfield and tell them both what I say now. Not only that but Mr. Parks Rasin was told the same thing by Mr. Charles N. Satterfield and so there could have been no possible mistake."

I then requested Mr. A. Parks Rasin to see me. He stated to me in person, that he told Charles N. Satterfield before the Democratic primary—"Henry Brown told me of his talk with you, that Will Usilton had told you if Ellwood Morris were nominated by the Senate by the Antis that he, Usilton, would not support him in the election." Yes, said Satterfield, and he had no business telling you that. "There can be no question about this statement having been made to me by Mr. Satterfield."

I think it is proper to publish these facts for this reason—It shows that if men like Walter Sutton made such statements prior to the primary, men who were not leaders nor office holders in the party, then they might have been overlooked. Even J. Hall Denny, the only Democratic member of the Board of Election Supervisors, holding a most responsible position, might have been excused for saying similar things for apparent reasons. "Now, gentlemen, I am a leader, the editor of the News, the apparent owner or lessee of Firemen's Hall on primary day, was guilty of such bare treachery in his heart and expressed in these things his treacherous intent—these things the public should know. All these statements, coupled with Urie's ticket indicated there was a deep design on the part of men prominent in Organization circles to knife the ticket at the election, if we had won in the primary. I find numbers of my friends believed it. This is now my honest belief. If names of other leaders and more proof be demanded it is at the disposal of the Antis, but I do not intend to do so."

This was no just reason, however, for Anti-Organization Democrats to cut the Democratic ticket, after it had been nominated, and defeat it, simply because men like Usilton harbored such designs and the fact that they believed they would undoubtedly have carried them out is no sufficient reason for my objection for Anti-Organization or Organization Democrats to defeat the regular Democratic ticket. At the same time, while this is my opinion, I can readily understand why a great many men in the rank and file of the Anti-Organization as well as some leaders resented the charges now being made against me. I believed it was the truth and they struck back saying they were fully justified in such conduct. The Usilton statement, industriously spread all over Kent, coupled with the conduct of John D. Urie in his hand-plucked Republican ticket, made so plainly and purposely to assist the regular ticket in its victory, in pursuance of the Usilton idea; these things all produced that bitterness which smoldered up to and broke out on election day. Treachery and treason in the party should be stamped out. But the idea of this fellow Usilton undertaking to designate judges to inaugurate the election is a disgrace to the party.

There were different ways to end the difficulty which confronted the Antis after the primary. I think the wrong way was adopted this time by many of my friends, and I deeply regret it. There should have been a conference and an endeavor to harmonize views. An open, honest, and fair discussion of the intentions would, in my judgment, have been a better way to settle the matter and fewer men would have been under suspicion than there are to-day because of the fact that such a fight would have been in the open.

The lesson is this: The Benedict Arnold is not in the ranks of the Anti-Organization. The chief Benedict Arnold is William B. Usilton, and so are his friends and supporters. Hereafter Usilton's and the News' rank and file editorials denouncing and condemning the Anti-Organization should have no more attention paid to them than to rats which are apt to scuttles any vessel they are found aboard. Simply exterminate them! He should be shot. He should be discredited. I find that his inoculation of this virus (which, by the way, he comes by most naturally), had quietly spread throughout Kent county, from one end of it to the other. I am frank to say that I never heard a word of his "dickie" until just before the election, nor a hint of it before the primary. I think every man in Kent county knows I should have denounced him openly, and I should certainly myself have taken vigorous steps to have thwarted his designs. The Arch Traitor is Usilton, and from what I have heard, since the election, I think there were others like him in Chestertown and other districts. Not to be invidious let the Sixth clear her skirts.

I should be very glad for anyone to give the names of either Anti or Organization Democrats with details as to what they heard them say. We all know what "USILTONISM" is. He has been held up to public scorn by his own words. He refuses to deny the charges but has kept him by men of reputation in the community. His very silence condemns him. Personally, after Usilton's refusal to meet these gentlemen in Mr. Beck's office and face the serious charges made against him in such public manner, I would have believed the word of Henry Brown as to what he said to me, and the oath of William B. Usilton. I have heard others express the same opinion. Let us, therefore, dismiss him from all further consideration as a Democrat of any stripe whatever, but regard him as he is and should be regarded a political Patria—a traitor to his party, and the prime cause of so many Democrats splitting their ticket in the last election. He, the last of all, has the right to declare outcasts those who, because of what he said, left their party. Rather than "Usiltonism" let us welcome "Urieism;" at least we know he is against us. How a re-naming of the party can be brought about is more than I can conceive. The bitterness is too deep on both sides. It was so in the primary. Remember the articles which appeared during the primary campaign in the Kent News of personal abuse against my friends and myself. At that moment one of its editors was a traitor in his heart to the party. I determined not to notice the attacks. I kept quiet then because I thought it was politics for my friends to do so. But I made up my mind, and publicly stated it, that after the election I should answer with a letter in the TRANSCRIPT every false accusation hereafter made against my friends or myself. Do not let it be thought for an instant that I have no other information in my hands as damning against those who are against Usilton. I shall feel at perfect liberty to use the same should occasion arise.

Now as to the future. I am done with this unpleasant subject and others unless they are reopened. Let us try and stop washing in public our troubles. Let us see if we can get together and beat the Republican party. Do not blame the Antis alone. Remember a large number of Organization men did not vote the Organization ticket they helped to nominate. Let every Anti-Organization man be ready to fight if need be, but let him at the same time feel that in the future the spirit of concession should prevail among party men. As for myself I wish nothing. I do not desire to lead. I can fight in the ranks. My political views are clean cut and clear. I am a Democrat. I am opposed to the present State Democratic machine, and to all those who aim to sustain and prolong its existence. I am in favor of the policies of the Wilson administration. I do not believe Senator Smith and his friends are. I recognize their right to differ with me. When they win a primary I am with them heart and soul, and I hope hereafter every friend of mine will vote to elect the Democratic ticket when nominated by Democrats without the use of money. Mark that! I want no more fights in the primary like the last. This is capable of two constructions. An honorable fight among Democrats in the open is one. Another is a dishonest fight made by traitors, who never intend to support a Democratic ticket which they fight if it should be nominated against their will. This means the Usiltons, Uries, Republicans and other well-known undesirables who will, if necessary, be named hereafter.
