

License Fund To Repay Loss.—The money received from the dog license fees in Kent is kept by the treasurer of the county, and it will be used to pay damages for injury and loss of sheep, poultry and live stock. Any inhabitant who has live stock destroyed by dogs may apply to a justice of the peace, who shall appoint three disinterested persons to appraise the damages. The report shall be reviewed by the county commissioners and they shall award the amount they deem fair.
