The Enterprise: Chestertown, Md. Dear Editors:

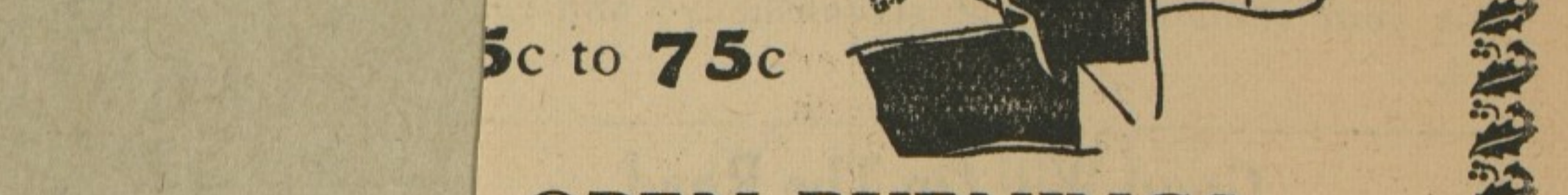
