ELECTION TEST FOR SCHOOLS CHORAL UNION FERRY SERVICE

Despite the apparent quietness of the past week the coming municipal election continues to head the list of timely topics. The quiet of the past few days is just the lull before the storm. The battle will be renewed with new fury on Saturday as the opposing forces take the issue of delinquent taxpayers and their right to vote before a special session of the Circuit Court for Kent county.

As was pointed out here last week the current election campaign already is productive of good. There are certain phases of the town charter that need clarifying. The right to deprive delinquent taxpayers of a vote is just one of the provisions that should be made clearer.

The charter, as with the case of most such instruments for the first few years of their existence, fails to make full provisions for the carrying out of its intent. For instance no means is provided for notifying the election officials with the names of eligible voters, those who have complied with the tax law. This information, naturally, should and does come from the Town Clerk but the charter makes no such provision.

It is well to bring such instruments of government up-to-date every few years even if a bitter election campaign is necessary to bring it about.

Whether or not you are in favor of better school facilities you must admire the courage and devotion to purpose of the Parent-Teacher organization of a Kent county group rallied to the school cause yesterday and visited Annapolis along with delegations from 20 other Maryland counties to seek an additional \$600,000 for Maryland schools.

The slogan of this group was to the effect that the dollar shouldn't be put ahead of the youth of the State. And right they are. But they, or anyone else, will have a hard time convincing a lot of people, including countless parents, of the truth and wisdom of their cause.

There is a greater need of education today than ever before, particularly the brand of education dispensed by the secondary schools which teaches of the lives of the nation's great. The nation today needs nothing so much as a return to the thriftiness of the days of Benjamin Franklin.

The Homemaker Clubs of the county have hit upon the right idea in the formation of a Choral Union. No movement in recent years will come closer to bringing the various women's groups of the county together.

Nothing, perhaps, has had greater significance in the spread of the Rotary movement over the world than the fact that the members devote a portion of each meeting to song. A man forgets his cares and worries when he sings. And a man unbends, relaxes, becomes a good fellow as he lets his voice mingle in harmony with his neighbors.

What has been true of the worldwide extension of Rotary certainly can be true among the women's clubs of the county. A new spirit of comradeship should be born. Sing, Sister, Sing.

Delegate Wilbur Ross Hubbard reports today the successful fight to retain in the Governor's budget a subsidy for the Tolchester Ferry Company. Most people look with disfavor upon the subsidizing of private business and many here in Kent county probably feel that the Tolchester Company has done little to deserve the financial aid it receives.

But, take the Tolchester Ferry a year and see what inconvenience it will cause. Until a bridge or a better ferry system is provided we'd better stick by the Tolchester Company. After all a little sugar is better than no sweetness at all.

Meteorite May Be Slag Or Bay Rock

Find Soft Coal And Sea Shells In Mass

The 200-pound purported meteorite, discovered some weeks ago near Rock Hall, may turn out to be so much slag or a lump of rock-like material from the bottom of the Chesapeake Bay. Prof. Jesse J. Coop, Washington College physicist, examining the substance, reported signs of soft coal and sea shells which led him to believe that the substance was not a meteorite as first supposed.

A portion of the huge mass was sent to the Philadelphia Academy of Natural Sciences for further study.

The purported meteorite was discovered on the farm of Louis Aiello, near Rock Hall, when the last heavy snowfall melted away. A burned fence post nearby and the report of residents in the neighborhood of a heavy, rumbling noise during the snow storm led to the belief that the mass was a meteorite.

Town Election Fight Goes Into Court Here With Hearing Saturday

Wilmer Seeks Votes For 72 Delinquents

CLAIMS ALL REGISTERED

Balloting Due Monday 9 A. M. To 6 P. M.

Chestertown's coming municipal election will go into the courts on Saturday morning of this week as the Judges of the Circuit Court for Kent County sit in special session here on the petition of Philip G. Wilmer, candidate for mayor, asking that the supervisors of elections for the town be enjoined from refusing the votes of a number of persons whose names still appear on the registration books.

The petition lists the names of 72 residents of Chestertown whose names are said to remain on the registration books but who admittedly haven't paid all of their taxes to the town. The petition maintains that since the names haven't been stricken from the books that the people are entitled to a vote.

Scott Beck is representing Mr. Wilmer, while Harrison W. Vickers, attorney to the Mayor and Council, will represent the judges of the election, Lawrence G. Brown and W. F. Malin.

The Charter provided for the striking off of voters upon due notification and since notification was not given it is contended that these 72 names remain upon the books.

The Mayor and Council, however, through their attorney, Mr. Vickers, contend that the purpose of the Charter is to restrict the right to vote to those citizens who have paid their taxes.

The hearing will climax arguments that have flown thick and fast during the past two weeks over the eligibility of delinquent taxpayers to participate in the municipal election.

A mayor and two councilmen, the latter from the second and fourth wards, will be chosen by the voters next Monday, all of the registered voters casting ballots in the mayoralty test but only those residing in the confines of the second and fourth wards will be permitted to vote for the candidates from these divisions.

The mayoralty race, naturally, is attracting the most interest with the three-cornered fight in the fourth ward running a close second.

In the mayoralty test Mayor Charles N. Satterfield, the incumbent, is being opposed by Philip G. Wilmer, young business man. The latter is centering his attack on the position of town clerk, where his platform calls for a reduction in salary of at least 30 per cent; the police force, where he favors a reduction in the number of men employed; and on the post of town engineer.

In the Fourth Ward race the candidates are George W. Rash, incumbent, Harry W. Fallowfield and Dr. J. S. William Jones. The latter, not aligned with either faction in the election, has the support of a large number of women voters in the ward.

In the Second Ward another interesting fight is in prospect as George W. French, incumbent, is opposed by Charles F. Wheatley, banker.

Laurence G. Brown and W. F. Malin, supervisors of town elections, have announced that the balloting will take place in the office of the Register of Wills in the Court House, the polls opening at 9 A. M. and closing at 6 P. M.

TOLCHESTER SUBSIDY BACK IN BUDGET

Kent Merchants In Fight Against Sales Tax Plan

Senate Votes Measure Down 19-9

Kent county merchants joined with others from all sections of the State in a trek on Annapolis today to fight the adoption of a two per cent sales tax to raise \$6,500,000 for relief, old-age pensions and reduction of the real estate levy.

The group from Kent included Samuel Dorf and A. S. Turner, Jr., as well as merchants from Rock Hall, Millington and other sections of the county.

The assemblage of merchants had been planned for some time but some of the necessity of their appearance was lopped off last night as the Senate voted 19 to 9 against the sales tax plan, labeling it "absurd" and "ridiculous."

Following the action of the Senate the House of Delegates voted 56 to 53 to "express the sentiment of the House" for a two per cent sales tax as a last resort for relief funds.

Senator Arthur H. Brice, of Kent, was listed with the 19 members of the upper branch of the Legislature who opposed the sales tax plan.

The action of the Senate leaves the State without any tangible plan to put in the legislative hopper by Friday, the dead line set by the Federal Government. After that time the FERA will not provide any further funds for the Maryland relief bill.

Before the session, the Senate voted 17 to 10 to admit the press to the meeting.

Sentiment of the members in general agreed on one thing: That great economies can be effected in the administration of relief in the State, and that every community should be made to share some of the taxes imposed to raise the State's share for the purpose of making the people relief-tax conscious and bringing pressure to bear to eliminate "extravagance."

The plan which the members vetoed and which had been agreed to by Governor Nice, his advisers and sub-committees of both houses in conference yesterday, was as follows:

"We recommend the passage of a straight two per cent general sales tax, estimated to yield probably \$6,500,000, out of which there shall be dedicated and ear-marked for emergency relief for a period of three years, the annual sum of \$3,500,000, and out of the returns for the first year there shall be dedicated the sum of \$1,500,000 for old-age pensions.

"The balance of revenue thus obtained, less the expenses of administration, shall be allocated to the servicing of the outstanding \$12,000,000 loan issued for relief purposes in 1933, and any and all balances, plus the amount saved in serving the \$12,000,000 bond issue shall be set aside and ear-marked for the reduction of the State tax rate in the next State tax levy bill."

Kent Parents In Annapolis To Aid Fight For Boost In School Budget

Would Increase Amount By Some \$600,000

FIVE POINTS IN PROGRAM

Group Hears Address By Governor Nice

More than 20 Kent countians were among the 500 parents of school children in 21 of Maryland's 23 counties who assembled in Annapolis yesterday to ask Governor Nice and the General Assembly to boost the State school system's budget allotment by some \$600,000.

Meeting in the old Senate Chamber they passed a five-point resolution urging the increase. The resolution, however, was passed neither unanimously nor without debate, the dissenters holding out for still larger demands.

The five points covered in the resolution, with the approximate amounts required to meet them were:

1. That the Legislature provide an additional \$87,000 to cover the cost of high school bus transportation instead of paying only half the cost as at present.
2. That approximately \$48,000 be provided for additional teachers to take care of increased enrollments. No such provision is made in the present budget.
3. That approximately \$58,000 already requested for normal schools but omitted in preparing the budget be included.
4. That one-half the pay cuts imposed on State teachers be returned. The point was made in support of this request that living costs have advanced 8 per cent since January 1 of this year. It was on this point in the resolution that the assemblage argued considerably, one faction holding out for a demand that the entire pay cut be restored. As it stands the restoration of one-half will require approximately \$175,000. The entire pay cut restoration would require approximately \$425,000.
5. That there be an immediate restoration of the county tax reduction fund to its status of two years ago. This would require about \$250,000.

The completed resolution was submitted to a joint meeting of the Ways and Means and Education committees of the House of Delegates and the State Senate. Subsequently the group of parents were addressed by Governor Nice, following which a delegation representing the group called on the Governor at his office for formal presentation to him of their demands.

Prof. R. C. Lamb of the Naval Academy faculty, presided at the meeting, assisted by Mrs. H. Ross Coppage, president of the Maryland Congress of Parents and Teachers.

GROUP HOURS ADDRESS BY GOVERNOR NICE

Parents From Various Sections Of County In The Group Included The Following:

MEETING IN THE OLD SENATE CHAMBER THEY PASSED A FIVE-POINT RESOLUTION

URGING THE INCREASE. THE RESOLUTION, HOWEVER, WAS PASSED NEITHER UNANIMOUSLY NOR WITHOUT DEBATE,

THE DISSIDENTS HOLDING OUT FOR STILL LARGER DEMANDS.

THE FIVE POINTS COVERED IN THE RESOLUTION, WITH THE APPROXIMATE AMOUNTS REQUIRED TO MEET THEM WERE:

1. THAT THE LEGISLATURE PROVIDE AN ADDITIONAL \$87,000 TO COVER THE COST OF HIGH SCHOOL BUS TRANSPORTATION

INSTEAD OF PAYING ONLY HALF THE COST AS AT PRESENT.

2. THAT APPROXIMATELY \$48,000 BE PROVIDED FOR ADDITIONAL TEACHERS

TO TAKE CARE OF INCREASED ENROLLMENTS. NO SUCH PROVISION IS MADE IN THE PRESENT BUDGET.

3. THAT APPROXIMATELY \$58,000 ALREADY REQUESTED FOR NORMAL SCHOOLS

BUT OMITTED IN PREPARING THE BUDGET BE INCLUDED.

4. THAT ONE-HALF THE PAY CUTS IMPOSED ON STATE TEACHERS BE RETURNED.

THE POINT WAS MADE IN SUPPORT OF THIS REQUEST THAT LIVING COSTS HAVE ADVANCED 8 PER CENT SINCE JANUARY 1 OF THIS YEAR.

IT WAS ON THIS POINT IN THE RESOLUTION THAT THE ASSEMBLAGE ARGUED CONSIDERABLY,

ONE FACTION HOLDING OUT FOR A DEMAND THAT THE ENTIRE PAY CUT BE RESTORED.

AS IT STANDS THE RESTORATION OF ONE-HALF WILL REQUIRE APPROXIMATELY \$175,000.

THE ENTIRE PAY CUT RESTORATION WOULD REQUIRE APPROXIMATELY \$425,000.

5. THAT THERE BE AN IMMEDIATE RESTORATION OF THE COUNTY TAX REDUCTION FUND TO ITS STATUS OF TWO YEARS AGO.

THIS WOULD REQUIRE ABOUT \$250,000.

THE COMPLETED RESOLUTION WAS SUBMITTED TO A JOINT MEETING OF THE WAYS AND MEANS AND EDUCATION COMMITTEES

OF THE HOUSE OF DELEGATES AND THE STATE SENATE.

SUBSEQUENTLY THE GROUP OF PARENTS WERE ADDRESSED BY GOVERNOR NICE,

FOLLOWING WHICH A DELEGATION REPRESENTING THE GROUP CALLED ON THE GOVERNOR AT HIS OFFICE

FOR FORMAL PRESENTATION TO HIM OF THEIR DEMANDS.
