**June Weather.**—A regular storm period central on the 17, extending from the 15 to 19. Moon in perigee on 16. During that period many afternoon thunder storms will be natural. As a rule a yearly maximum of rainfall is to be expected, generally, during the June solstice. A reactionary storm period is central on the 22, 23 and 24. The moon is at the last quarter and on the celestial equator on the 21, and these facts will cause decided tendency to electrical storms at the beginning of this period. We may reasonably look for a period of abnormal electrical activity, covering and next to the 21, 22, 23 and 24. Afternoon and evening thunder storms may reasonably be counted on about this time. Haymakers and others who might suffer inconvenience and loss, will do well to watch conditions and plan their work accordingly, through all this solstice period. We repeat our annual warning against the danger in taking shelter under green trees during the June thunder storms. If all our readers see the correct statistics of fatal lightning strokes, as a result of running under trees in June storms, our oft repeated warning would be more appreciated.

A regular storm period begins on the 27 and extends to July 2. This period is central on the 29th, with the moon in conjunction with the earth and sun at a solar eclipse node and moon at greatest north declination. The crisis of this period will fall on and touching the 28, 29 and 30.

**PURSE NET LAW.**

The fishermen of Kent county have been in a quandary to know what to do in reference to purse net fishing as the authorities could not be induced to send the law to them. The News has succeeded in procuring a copy which is as follows:

**CHAPTER 740.**

An act to add two new sections to Article 39 of the Code of Public General Laws, title Fish and Fisheries, sub-title, Head of the Bay, to follow Section 2, and to be designated, respectively, as Section 2A and Section 2B. Whereas fishing with purse net has a tendency to destroy the stock of food fish in the Chesapeake Bay and its tributaries by causing greater quantities to be caught than are marketable and in such event frequently allowing the classes of fish to be sold to fish factories, and whereas as that practice of catching fish by said means during the spawning season has a tendency to destroy one of the most productive industries of the State, therefore:

Section 1. Be it enacted by the General Assembly of Maryland, That two new sections, to be designated, respectively, as Section 2A and Section 2B, of the Code of Public General Laws, title, Fish and Fisheries, sub-title, Head of the Bay, to read as follows: 2A. No person shall at any time be allowed to fish with purse nets at any point in the Chesapeake Bay north of a line drawn east from Sandy point on the Western Shore due east to Love Point on the Eastern Shore of Maryland. 2B. No person shall fish with purse nets within the State of Maryland south of the line drawn from the line aforesaid due east to the Eastern Shore without first obtaining a license from the Comptroller of the Treasury, and the applicant shall pay the sum of \$25 for each and every purse net owned and operated by him, when upon the said Comptroller shall issue to such applicant a license or licenses to operate such purse nets and all moneys arising from said licenses shall be paid into the State Treasury for the maintenance of the State oyster navy, and any person failing to procure such license and violating the provisions of this section shall be deemed guilty of a misdemeanor and on conviction thereof shall be subject to the fines and penalties imposed by Section 3 of this Article, and the penalties imposed by the Statutes of Maryland for failing to procure license wherever required by law.

**WHOLE GANG CAPTURED.**

**Desperadoes Who Robbed the Post-Office at Sassafras and Shot the Postmaster Now Safely Behind the Bars.**

The desperadoes who some weeks ago robbed the postoffice at Sassafras and shot the postmaster, were caught recently near Lancaster, Pa. They robbed a postoffice in that section and were rounded up, and after a battle three of the four were arrested, the other one who got away at the time was later apprehended in Philadelphia.

The appearance of the gang answered that of the one wanted for the Sassafras job, and photographs of them were sent not only to the postmaster at Sassafras, who had a brief but intimate acquaintance with them, but also to those persons in the lower part of Cecil who saw the men at different points, and all readily identified them. The man who escaped from Lancaster and was afterward caught in Philadelphia was recognized as the one who had shot the Sassafras postmaster, and when arrested he had a 38 calibre revolver and \$79 worth of stamps with him. He has not yet been tried, but the other three were given eleven years each for the Pennsylvania job, and detainees were filed to hold them when the sentence expires so that they may be tried for the Sassafras affair.

After the gang did their work at Sassafras they went across towards Reboyl's wharf; then for some reason they tramped boldly back, across Bohemia bridge, where they held up a man and got a small sum of money; then they went through Chesapeake City and across to the Delaware Railroad and up to Porter's. At that point they divided their force, two of them going to Newark and the other two to Delaware City. Later they again joined and moved on up into Pennsylvania, where to the relief of the public they were caught.

**ODESSA AND TOWNSEND ARE "DRY"**

**The Law and Order League of Townsend Have Filed Two Remonstrances.**

Odesa and Townsend, although in a 'wet' territory, are both 'dry,' and will probably remain so for several days at least. The two hotels in Odesa closed their bars at 11 o'clock Thursday night of last week, and the Townsend hotel discontinued business at an early hour Friday morning.

The trouble in Odesa is that the hotel keepers, J. Harry Massey and Calvin P. Siddman did not have the necessary number of freeholders when they made application for license at the March term of court, and their old license expired on June 12th.

At Townsend there was a remonstrance against the application of James L. Dickinson when he applied at the March term of court, and he withdrew his application. W. T. Bramble who has been employed as his clerk, is applying at this term of court for a license. The Law and Order League of Townsend is opposing the granting of this license, and have filed two remonstrances against the applicant, and propose to keep the town "dry" if possible.

The Law and Order League of Townsend is also watching several people of that place who are suspected of selling intoxicating drinks, and some arrests are likely to be made in a few days.
