SPRANG A SURPRISE!

Republicans Collected A Large Contribution From The Standard Oil Company In 1904—Roosevelt Laid Low By The Charge.

Ex-Judge Alton B. Parker, of New York; Senator John W. Danahy, of Virginia; Senator Isidor Rayner, of Maryland; Col. Alexander S. Bacon, of New York, and a number of other speakers addressed a large and enthusiastic Democratic mass meeting last Monday night in Richmond Market Hall, Baltimore.

Police Marshal Farnas estimated the attendance inside and outside the hall at 6,000.

A sensation was created by a charge made by Judge Parker that Mr. George E. Cotton, while chairman of the Republican National Committee in 1904, solicited a large contribution from the Standard Oil Company, but that only \$100,000 was given, which was spent in electing Mr. Roosevelt. Judge Parker said that he expected this would bring out another letter from the President.

When he reproached Mr. Roosevelt for using Governor Haskell's record against Mr. Bryan and said that the Democratic standard-bearer had "earned the right to be saved from the gallows," there was an outburst of enthusiasm lasting several minutes.

An overflow meeting outside the hall was addressed by Colonel Bacon and Mr. S. S. Field.

In an interview Judge Parker said the Democrats ought to win in New York and in the nation because they are united and really want to win, instead of being split as they were in 1904.

In his travels through the West this year he declared he found a great change of sentiment toward the Democrats among people who said that in 1904 they had been "led to regard him as a kind of 'devil with horns.'"

RAPS ROOSEVELT IN PULPIT.

Negro Pastor Calls President Ally of Hearst in Foraker Case.

Rev. Dr. C. R. Ransom, pastor of Bethel African Methodist Episcopal Church, in West Twenty-fifth street, Phila., made the startling statement from the pulpit that he would hold his arm in the fire until it shriveled before he would use it to cast a vote for William H. Taft, the Republican candidate for President. Previously he had attacked President Roosevelt savagely. His theme was "The Aims of President Roosevelt and Mr. Taft toward Senator Foraker in the Brownsville Affair." The preacher said that for twenty-six years he had voted for every Republican candidate for President. Speaking of what he called a partnership between President Roosevelt and William H. Hearst, in relation to Foraker, he said: "This is the same Hearst who ran for Mayor and for Governor on the Democratic ticket who, by the exigencies of politics, has become the side partner of the President. This is the same Hearst whom President Roosevelt charged, through Secretary Root, with being an assassin of the President of the United States, and who now seems to be received with open arms by the man who accused him of being particeps criminis in the death of his predecessor."

When Archie Roberts, a Federal officeholder, sought to defend the President, the audience yelled, "Put him out!" "Sit down!" and "Shut up!" Dr. Ransom protected him and said Archie was an uncle of "Charlie" Anderson, Collector of Internal Revenue. The preacher said no self-respecting negro could vote the Republican ticket this fall.

"PROXY" TAFT.

The St. Louis Post-Dispatch, one of Mr. Joseph Pulitzer's newspapers, summarizes the Democratic case against the Roosevelt administration as follows:

1. It has been extravagant and wasteful.
2. It has attempted to popularize war.
3. It has gloried in Philippine imperialism.
4. It has menaced the states with Federal usurpation by means of constructive jurisprudence.
5. It has recklessly undermined confidence in our business methods, causing panic, depression and suffering.
6. It has profited by the political contributions of corporations acting legislative.
7. It has spoken vociferously against the malefactors of great wealth but it has not brought one of them to justice.
8. It has bullied Congress, threatening to do as it pleased, law or no law.
9. It has assailed the courts when their judgments were contrary to its wishes.
10. It has maintained the highest tariff ever known in a free country, and has made no move in favor of income and inheritance taxes.
11. It has constantly demanded law and more law for the prosecution of trusts, although existing laws are held by it to be too drastic for enforcement.
12. It is now attempting to round out a career of willfulness, greed, ambition and tyranny by forcing the election of a personally excellent and amiable proxy."

These are legitimate issues; they are timely issues; they are Democratic issues. As the opposition candidate it becomes Mr. Bryan's privilege and duty to present them with all the skill and ability at his command.

His opportunity lies in an appeal to Democrats and to that great element in the electorate that is tired of extravagance and of militarism, of imperialism, of Rough Riderism, of centralization, of personal government, of big stick administration and partnership with predatory plutocracy.

Let Mr. Taft be the proxy. Let Mr. Taft be the heir to My Polities. But let Mr. Bryan be the Democratic candidate for President of the United States.

All Tickets in Five Parties in the Field.

The records at the Executive offices show that five parties will be represented on the official ballot in one way or another at the coming election. They are the Democratic, Republican, Prohibition, Socialist and Independence. The former three all have full sets of nominees for Congress, together with Presidential electors, and the certificates were filed in the usual way. The Socialists and Independence each have Presidential electors, whose names will appear on the ballot through petition. The petition method had to be resorted to because total vote at the last general election in the State. The law requires 500 signers to a petition to have a Congressional candidate's name placed on the official ballot, and 500 for a State candidate, and the petitions filed Thursday contained the required number of signers. In addition to Presidential electors, the Socialist party also has a candidate for Congress from the Sixth district, whose name will appear on the ballot through petition. The last of the certificates of nomination to be filed came in Thursday morning. They were those of the Democratic and Republican candidates for Congress from the Third and Fourth Congressional districts of Baltimore City. The petition of the Independent and Socialist parties for Presidential electors were not filed until the afternoon. The executive offices remained open until midnight in case there should be any petitions for the placing of Congressional candidates or electors on the official ballot. Prior to the filing of the petition by the Socialist party, that party had filed certificates for Presidential electors and congressional candidates, but these were declined, because of the 1 per cent vote provision. The following is the complete list of Congressional candidates whose names will appear on the official ballot:

First District—J. Harry Covington, Talbot county, Democrat; William H. Jackson, Wicomico county, Republican; Jacob W. Wheatley, Talbot county, Prohibition.

Second—J. Fred C. Talbot, Baltimore county, Democrat; Robert Garrett, Baltimore county, Republican.

Third—Harry B. Wolf, Baltimore city, Democrat; John Krommiller, Baltimore, Republican; Roswell V. Whitehurst, Baltimore, Prohibition.

Fourth—John Gill, Jr., Baltimore, Democrat; John Philip Hill, Baltimore, Republican; Charles R. Woods, Baltimore, Prohibition.

Fifth—George M. Smith, Prince George's county, Democrat; Sydney E. Mudd, Charles county, Republican; Samuel W. James, Baltimore, Prohibition.

Sixth—David J. Lewis, Allegany county, Democrat; George A. Pearce, Allegany county, Republican; Harry M. Cuppert, Garrett county, Prohibition; L. V. Young, Washington county, Socialist.

Former Senator Made Court Clerk—Colonel Luther H. Gadd, formerly Senator from Anne Arundel county, has been appointed Chief Deputy Clerk of the Court of Appeals in place of Joseph T. Brockhead, resigned. R. Lee Waller, of Salisbury, has been appointed to the clerkship vacated by Gadd.
