### FOREIGN NEWS.

#### ARRIVAL OF THE GREAT WESTERN.

Four Days Later from Europe.  
The steamship Great Western arrived at New York on Tuesday evening at 8 o'clock. She brings four days later intelligence. The Great Western encountered heavy seas and heavy winds during a good part of the passage.

The number of passengers is 145. Among them we notice Hon. Mr. Jenifer, U. S. Minister to Austria, and his attaché, Hon. Mr. Bulwair, late U. S. Charge to Naples; Hon. C. Hughes, do. Hagen, J. H. Vernon, Member of the British House of Commons from East Bedford, and other distinguished individuals. Her freight is also very large and valuable.

Great praise is due to the Agents of this vessel, that notwithstanding her late arrival at Liverpool, she had got ready for sea again in four days, with a full cargo of goods. Some dissatisfaction has been expressed by the holders of Pennsylvania stock, that faith has not been quite kept with them in the matter of their bonds. The payment of the interest, they gratefully acknowledge, has been resumed, and provision has been made for the payment of the arrears, but the certificates of the new stock bear interest at the rate of 4 1/2, whereas the former were at the rate of 5 and 6 per cent.

A fire of a very destructive character, involving the loss of property to the amount of several thousand pounds, occurred at Altermansbury, the well known nucleus of Manchester warehousemen in the city of London, Aug.

The Ordnance authorities have reported in favor of Benningfield's electric gun, which at an expense of £10, continues for eighteen hours discharging balls to kill at the distance of a mile, more than could be discharged in the same time by two regiments of infantry.

Among the Railways projected for the British Colonies is one from Demazara, bro't out under the auspices of the Gladstones of Liverpool, and many other highly respectable merchants, both of Liverpool and London.

The Spanish and Portuguese Slave Trade, recently convicted at Exeter of murder, have been respited till the 6th of September, in order that certain legal points raised by their counsel may be argued before the Judges.

The late Mr. Somers, M. P., that great ship-owner, has left upwards of £500,000 in personal property alone. He has bequeathed £70,000 to his widow with a request, not a command, that she will not marry again, fearing that there is no man worthy of her. "She deserves," says he, in his will, "the best of husbands, as she has been to me the best of wives."

#### LATEST FROM MEXICO.

Herrera Elected President—Almonte Secretary of War, &c.  
The Baltimore Republican and Argus has received the following highly important letter from a friend at Pensacola. The news is brought by the U. S. ship Saratoga, which arrived at Pensacola on the 31st of August, bringing dates from Vera Cruz to the 18th ult.

PENSACOLA, Aug. 31st, 1845.  
Herrera is elected President of Mexico. Almonte is Secretary of War and expects to be Secretary of State. Congress has authorized the Executive to borrow 15,000,000 of dollars, and to raise 25,000 troops. The policy of the Mexican government has undergone a change. They cease to speak of the U. States as the party with whom they are to wage war, and have taken the ground that they are arrayed only against their revolted province of Texas, which is to be subdued at once. This they have effected by a sudden and vigorous invasion, before a sufficient force can be opposed to them. For this purpose, Gen. Paredes has marched to Matamoros, on the Rio del Norte with 8,000 men. They are equipping their Navy, and increasing the number of their gun-boats. Troops have been sent to Tampico, in the steamer Montezuma. Mexico is convinced that England has persuaded her to take a false step, in order to acknowledge the independence of Texas; and that no aid is to be expected from that quarter.

The Saratoga exchanged salutes with Vera Cruz, and a better feeling than could have been expected, grew out of the observance of that courtesy, though the newspapers continued to be abusive. I have thus given you a brief but accurate summary of the news by the Saratoga. When you get it, it will probably be the latest received at Baltimore, and may therefore be acceptable.

P. S.—All Mexican statements, particularly newspaper statements, are to be taken with caution. Mind, I only vouch for the directness of the channel thro' which this news comes, not for the truth of the intelligence. Many circumstances induce me to doubt the important parts of it, such as Paredes' army, &c.

INFORMATION FROM THE ARMY.  
We take the following extract from a letter published in the Picayune of the 5th instant:  
CORPUS CHRISTI, Aug. 30, 1845.  
The position taken by General Taylor is one of extreme beauty; and when the eye first rests upon his camp, clustered with a thousand spotless white tents, along the shelly margin of the shore of Corpus Christi bay, irresistible bursts of admiration follow! It is a position of security as well as beauty.

His tents are pitched on a piece of table land that reaches about a quarter of a mile to a range of hills; at the distance of half a mile from the crest of these, he has stationed, as an out-guard, a force of one hundred and twenty hardy and well-tried Texans, to whose fidelity is intrusted this otherwise assailable point. Major Gally, commanding the volunteers from N. Orleans, is intrusted with guarding the extreme left, whilst the extreme right is safely guarded by Colonel Twigg, command-

ing the 2d dragons. The centre is composed of the 3d, 4th, and 7th regiments of infantry.

The commanding general has thrown up a field-work, a wall of shells and sand, six feet thick, and three hundred yards in length, on his right. In case of an overpowering attack from this quarter, the troops stationed outside of this wall are to retreat behind it. The whole length of the line along the shore occupied, appears to be about one mile and a half.

It is probably one of the healthiest and pleasantest spots in the world. From the earliest dawn, refreshing breezes invigorate the body, dissipate the intensity of the heat, and nerve the system to a healthful action. The cool nights invite weakness to repose, disturbed neither by the prying, nading flea, nor the buzzing mosquito.

The only drawback to continuing this encampment, is the scarcity of wood and water—the former the troops haul about three miles, and the latter is quite brackish, though I believe there are one or two small wells in the camp, which supply a very fair beverage.

The officers appear to enjoy themselves amazingly, considering they were supposed to be held in a cage. They purchase Mexican ponies at from \$10 to \$30, and exchange them for their own. The water contains both fish and oysters, both of a superior kind, and the prairie adjacent with rich flavored venison. Large and fat hives are slaughtered daily for the use of the troops—all which, with the liberal supplies of Uncle Sam, these occupiers of an independent nation's soil can get along mightily well with.
