

ANNAPOLIS, January 28, 1767.

THE COMMISSIONERS appointed by the Act of Assembly, entitled, *An Act for the Payment of the Public Claims, for emitting Bills of Credit, and for other Purposes therein mentioned*, hereby give Notice to all Persons who may receive Orders, or Assignments, from Others who have Claims against the Public, on the JOURNAL, or LIST OF DEBTS, That such Orders, and Assignments, will not be received by the Commissioners, where the Parties are entire Strangers to them, unless the same are regularly Attested, either by a Magistrate, or some well known Person of Credit.

And likewise, That Executors and Administrators, who have Sums to receive on Account of deceased Persons (in Case they also are Strangers to the Commissioners) must have the same Certified that they are so, from some Public Office, or by some well known Person of Credit, in the County where they reside.
